Barb (QasuGlana) Amarok is from Nome and is employed as the director of the University of Alaska Fairbanks (UAF) Northwest Campus. She earned a masters in Educational Leadership through the University of Alaska Anchorage and a Doctoral Degree in Indigenous Education through UAF. Barb worked with Nome Public Schools for 20 years and, most recently has served on the Nome School Board since 2010. Barb has served on the Sitnasuak Native Corporation Board of Directors since 2011 and as the Board Chair for three years.



Dr. Jessica Black (she/her) is Gwich'in from the villages of Gwichyaa Zhee (Fort. Yukon) and Toghotthele (Nenana). Dr. Black currently serves as an Associate Professor in the Department of Alaska Native Studies, Rural Development and Tribal Governance at the University of Alaska Fairbanks. Dr. Black received her bachelor's degree in Social Work (BSW) at UAF and her master's degree and PhD in Social Work at Washington University in St. Louis. Her dissertation and current research examine the relationship between governance and well-being among Alaska Native peoples, especially as it pertains to Tribal Stewardship and Cultural Connectivity. She resides in Fairbanks with her family, however, she frequently returns home to Gwichyaa Zhee to hunt, fish, gather and engage in other, important cultural practices.



Cathy Brooks is an Associate Professor in the Department of Alaska Native Studies and Rural Development at UAF. She teaches rural development courses tied to rural and community development, communication, entrepreneurship, business planning, and management.

Previously, Cathy was the instructor/program manager for the Festival of Native Arts and adjunct instructor for UAF's Interior-Aleutians Campus and UAF's Developmental Education Department. Brooks also served as the 4-H Youth Development Specialist in the mid-90s.

She and her family call Fairbanks home but, spend most of the summer on the Yukon River at her husband's family camp, where skills and traditions are shared with the next generation.

Laura Deloodeneenła Ekada (she/her) is a senior at UAF studying biology with a concentration in biomedical sciences and a goal of becoming a physician serving rural villages. Laura's family is from Koyukuk, Nulato, and Minto, where she has taken part in the cultural traditions of each place. She was raised in the small village of Minto by her grandparents.

Laura graduated from Mt. Edgecumbe High School in 2018. She wrestled, ran cross country and competed in track and field for Umpqua Community College for two years. She is the 2021 first runner-up Miss WEIO at the World Exhibition of Indigenous Events. She is the recipient of the Chief Andrew Isaac Leadership Award from Doyon.

At UAF, Laura is a BLaST scholar. She does research with Dr. Jacques Phillip. She is the president of the UAF beading club and the Troth Yeddha' Dance Group. Laura is a Peer Educator at the Nanook Diversity and Action Center. Laura also hosts a podcast called the Urban Auntie Show where she interviews guests on Indigenous culture and life.

Charleen Fisher, Ph.D. is Gwich'in, Koyukon, and Dena'ina from Beaver. She currently teaches at the University of Alaska Fairbanks as an Assistant Professor.

She has many years of experience as a K-12 certified teacher and principal. She has held multiple positions including Executive Director with the Council of Athabascan Tribal Governments and has served as the Chief of Beaver Village Council. She is currently serving on the Doyon, Limited, Alaska Humanities Forum, and the Gwich'in Social and Cultural Institute Board of Directors.



Reverend Dr. Anna Frank, Chief of Denakkanaaga was born in Old Minto, and raised living a subsistence lifestyle. She has dedicated her life to working on behalf of the Interior Native community; serving on numerous boards and committees. She currently serves as First Chief of Denakkanaaga and as the Elder Advisor to the Fairbanks Native Association Board of Directors. Frank was the first successfully ordained Indigenous woman in the world.



Dr. Richard Glenn served on the leadership team of the Arctic Slope Regional Corporation (ASRC), where he was Lands Manager, Senior Vice-President of Lands, and Executive Vice-President of Government and External Affairs. He was an elected At-Large director of ASRC for most of that time. Prior to that, he was a North Slope Borough (NBS) department director and worked for multiple NSB Borough Mayors as a department director (Barrow Gas Fields and Energy Management Departments). He was a geologist for his Alaska Native regional and village corporation subsidiaries and has a variety of experience in sea ice research, oil, gas, and mineral exploration and development projects, and permafrost. In Barrow, he served as crew member and co-captain of his extended family's subsistence whaling crew.

He was awarded an honorary doctorate from the University of Alaska Fairbanks for his contributions to the advancement of arctic science and engineering.

After college, Andrea returned home to Alaska to work as an investigative news reporter and anchor for KTVA CBS 11 News in Anchorage. Andrea was hired by U.S. Senator Lisa Murkowski in 2011 to be her Alaska Communications Director. Andrea previously served as Community Relations, Land and Resource Manager, and Vice President before being appointed as President and CEO of TKC in 2020.

Elizabeth Saagulik Hensley, J.D., is NANA Corporation's



Vice President of External and Government Affairs, responsible for developing, managing, and leveraging relationships with key stakeholders and partners to advance NANA's mission. Saagulik has worked for NANA as a staff attorney and as a partner at a private law firm, advising Alaska businesses and Alaska Native Tribes, organizations, and corporations. Her most recent position was as general counsel for Maniilaq Association, a Tribal nonprofit corporation that provides health, Tribal government, and social services to residents of northwest Alaska. Saagulik is a NANA shareholder and a Tribal citizen of the Native Village of Kotzebue.

Kaquatosh is the daughter of Barbara Beatus and the late Norman Beatus of Hughes. Her maternal grandparents are Johnson Moses and the late Bertha Moses of Allakaket. Anthony Mallott is President and CEO of Sealaska, an Alaska Native corporation owned by 23,000 Tlingit, Haida, and Tsimshian shareholders.

Anthony began serving as Sealaska President and CEO in June 2014. In this role, he guides the investment decisions that directly impact Sealaska's people, communities, and the natural environment, all while focusing on increasing profits and benefits for shareholders.

Anthony earned a Bachelor of Industrial Engineering Degree from Stanford University. He originally joined Sealaska in 2006 as the company's Chief Investment Officer and treasurer where he was responsible for the direction of treasury activities of the company and the management of corporate investment funds. Prior to Sealaska, Anthony was a vice president within Bank of America's capital markets, working in the portfolio and risk strategy group for 10 years.

Anthony currently serves as a Trustee and former chair of the Kootznoowoo Permanent Fund Settlement Trust, which benefits Kootznoowoo, Inc. shareholders. He has also served as a board member of the Rasmuson Foundation. a \$600 million private foundation that promotes a better life for all Alaskans; an investment committee member of the Alaska Community Foundation, a \$100 million philanthropic fund: and a Board Director of the Native American Bank.

Dr. Herb Schroeder started the Alaska Native Science and Engineering Program (ANSEP) in 1995 with a single Alaska Native student. Dr. Schroeder has received many honors, including a Presidential Award for Excellence in Science, Mathematics, and Engineering Mentoring in 2004, the Alaska Federation of Natives Denali Award in 2005, the greatest honor presented by the Federation to a non-Native, and in 2018 the George Norlin Award from the University of Colorado Boulder which recognizes a demonstrated and long-lasting commitment to excellence in his professional career and a devotion to the betterment of society and his community. In 2009, the National Action Council for Minorities in Engineering (NACME) honored him with the Reginald H. Jones Distinguished Service Award (Founders Award), which recognizes individuals whose efforts and accomplishments have resulted in increased underrepresented minority participation in the engineering workforce. In 2021, he was awarded the Friends of First Alaskans Ted Stevens Award by First Alaskans Institute.



Aaron M. Schutt is President and Chief Executive Officer of Doyon, Limited. He is responsible for working with the Board of Directors to set the overall direction of the Doyon Family of Companies and provide leadership to its senior management team. Aaron has worked at Doyon since 2006. Prior to being named President and CEO, Aaron served as Senior Vice President and Chief Operating Officer from 2008 to 2011

Aaron is Koyukon Athabascan and is an enrolled member of the Native Village of Tanana. He was born in Anchorage and raised in Tok. He is married to Marissa Flannery and together they have two sons and a daughter.



Ethan Schutt has spent two decades in roles of public service and executive management in Alaska. After graduating from Washington State University with a Bachelor of Science Degree in mathematics and then from Stanford Law School with a Juris Doctorate, he worked for Alaska Supreme Court Justice Walter "Bud" Carpeneti in Juneau.
