
Fall 2009 Additional Fees Form

Health Insurance

UAF advises all students to carry health insurance and requires coverage for all students enrolled in 9 or more credits, students living in university housing, and all international students with F-1 and J-1 visas (including Canadian students). If you don't already have health insurance, you must purchase the student health insurance provided through the university. Contact the Health Center at 474-7043 for more information.

Parking

If you will be parking a vehicle anytime, anywhere on any UAF facility, a current decal, pass or permit must be purchased and displayed on your vehicle. Metered parking requires payment of meters. (Time limits at meters apply.) Hourly, daily and weekly permits are available for purchase at kiosks conveniently located at Thompson Drive pullout, Nenana, Taku, U-Park, Reichardt, Museum, Elvey and U-Park lots. Single Vehicle Decal – Registers one vehicle for parking at any UAF facility

- Semester decal is \$35 for 8 or less credits (FPDG)
- Semester decal is \$68 for 9 or more credits (FPDF)
- Annual decal is \$124 (FPDA)

Multi-Car Decal – Registers multiple vehicles for parking at any UAF facility (*not available for campus residents*). Only one vehicle may be on campus at a time with this option.

- Semester decal is \$35 for 8 or less credits (FPDH)
 - Semester decal is \$68 for 9 or more credits (FPDY)
 - Annual decal is \$124 (FPDX)
- Additional Multi-Car Decals for _____ vehicles -maximum of 3 at \$10 each- (FPDU)

Post Office

- Semester PO Box is \$45 (FPBS)
- Annual PO Box is \$90 (FPBA)

Student Recreation Center

Students enrolled in 3-8 credits have the option to access the SRC facilities.

* Avoid \$100 late fee! Pay early!
- Deadline for 100 percent refund of tuition & fees is **Friday, September 11th**.
- Deadline for student-initiated & faculty-initiated drops & drop/swap (course does not appear on academic record) is **Friday, September 18th**.
- Deadline for 50 percent refund of tuition (tuition only, no fees refunded) is **Friday, September 18th**.
- Deadline for student-initiated & faculty-initiated withdrawals (a "W" grade appears on academic transcript) is **Friday October 30th**.
- Last day of instruction is **Monday, December 14th**.

Remember, the university does not drop you from your courses for non-payment!
