- Failure to pay this obligation or to make arrangements acceptable to UAF may result in the loss of all academic privileges at the University.
- My enrollment, meal plan, and/or grades may be withheld if I fail to pay my financial obligation.
- I understand that this promissory note covers all my current semester charges. This includes but is not limited to tuition, institutional fees, additional fees I elect, textbook loan, dorm room, meal plan, and adding classes after this promissory note has been accepted. I further understand that making changes to my account after this promissory note has been accepted, or the application of scholarships, loans or aid other than personal payments, will result in an automatic recalculation of my remaining monthly payments.
- This promissory note is due & payable according to the schedule listed, the end of the semester, or upon receipt of financial aid, refunds, or other funds received by UAF.
- This is the only notice I will receive of my debt before it is due.
- A charge of \$35.00 will be added to the bill for each payment not received on time.
- If I drop, withdraw, or discontinue attendance I will still have a financial debt to UAF.
- It is my responsibility to make payments even if I do not receive my financial aid or complete my classes.
- Defaulting on payments may result in the cancellation of this agreement, and may make me ineligible for future payment plans.

- Deadline for 100% refund of tuition & fees

Friday, September 18th

- Deadline for student-initiated & faculty-initiated drops
 - course does not appear on academic record
- Deadline for 50% refund of tuition
 - tuition only, no fees refunded

Friday, October 30th

- Deadline for student-initiated & faculty-initiated withdrawals
 - "W" grade appears on academic transcript
- Second \$100 late fee applied to overdue accounts.

Monday, December 14th

- Last day of instruction
