**IN SUBMITTING THE PRECEDING APPLICATION, I UNDERSTAND AND AGREE WITH THE FOLLOWING TERMS AND CONDITIONS:**

Completed applications will be processed in the order received by Residence Life, as indicated by the date of receipt. As apartments become available, you will receive an offer of occupancy. To accept an assignment, please send in \$200 for pre-payment of housing cost. The housing cost balance is due and payable in full at the time of check in, except students enrolled for the 12 week session. If you cancel your housing after accepting your assignment, you will forfeit the initial \$200. Couples, please submit a Financially Inter-Dependent form which can be found online at [www.uaf.edu/reslife](http://www.uaf.edu/reslife), or a copy of a marriage certificate or birth certificate of your children showing both you and your partner as parents with this application. Applicants planning to marry should apply for housing in advance and give an expected date of marriage along with a copy of the marriage certificate prior to move in.

1. Although both part-time and full-time students are eligible for summer housing, full-time students have priority. Full-time status is defined by the following minimums: three credits during Three - Week Sessions, six credits during Six-Week Session, twelve credits over the course of the summer.
2. Weapons are not allowed in Residence Life Facilities and must be stored in the weapons storage facility managed by the UAF Police Department.
3. Currently all UAF Facilities are non-smoking.
4. Each application will remain on file for the summer it is received. Please keep your contact information current with the Residence Life Office
5. Sorry, no pets, except aquarium fish in a 10 gallon tank or smaller, are allowed in Residence Life Facilities.
6. The University of Alaska Fairbanks provides equal housing opportunity and assigns apartments without regard to race, color, sex or national origin. Residence Life has facilities accessible for mobility-impaired residents.
