

4-H & FFA JR. MARKET LIVESTOCK AUCTION GENERAL INFORMATION



ADD-ONS

Additional dollar amounts or price per lb may be added to a specific animal after the high bid is announced. These "Add-Ons" may be from anyone wishing to give additional support and is a great way to support more than one auction participant.

PAYMENT

Payment for purchased animals is expected at time of sale unless other arrangements have been made. Checks made payable to 4-H Livestock Auction and credits cards will be accepted with at 3% service fee.

PHOTOGRAPHS

Buyers are requested to have a photo taken with the 4-H or FFA member and animal they purchased directly after the bidding for that animal ends. You will recieve a copy of your photograph as soon as they are available.

SLAUGHTER

All purchased animal will be transported to and slaughtered at Alaska Meat Packers unless other arrangements have been made. If you choose not to have your animal slaughtered, you may take possession of the animal after 6:30 pm on Labor Day. Discus specifics with your 4-H member and at the Auction check out.

Current slaughter fees: Beef \$195 Hogs- \$145 Goats/Lambs- \$95 Current butcher fees: \$1.25/lb cut & wrap, \$1.45/lb vacuum seal

Slaughter fees, butchering and processing prices subject to change without notice.

Small Stock will be butchered Monday, Sept 1st and delivered by 4-H/FFA members as soon as possible. A \$25 slaughter fee will be assessed at check out.

The official bidder for the 4-H Charitable Buyer's Club will be designated by the 4-H Livestock Committee.

USE OF ANIMALS

Donations not only support 4-H youth, they will help support those in need in our community as well. The processed meat from the animals purchased through the Club will be donated to local charitable organizations for distribution to those in need.
