- E. VRBO for State Horse Contest Sarah will check to see if we can get a refund if needed before booking. \$198/night. With a \$100 travel fee for competitors, it should cover the cost of lodging and food.

- F. Eliza reached out to us to see if we would be interested in running the Chuckwagon for the summer barrel series. This would potentially be a weekly commitment. Need to see if there are parents/members willing to do this.
