(FOR THE PURPOSE OF THE FOLLOWING INTERVIEW TRANSCRIPTION, "Q" WILL BE USED TO REPRESENT INVESTIGATOR SCOTT JOHNSON, "B" WILL BE USED TO REPRESENT INVESTIGATOR LANTZ DAHLKE , AND "A" WILL BE USED TO REPRESENT JASON THEO WALLACE.)

Q: thanks you guys, appreciate it

B: watch your toes, dude

Q: hey Jay

A: how you doin' man?

Q: good, how're you doin'?

A: good

Q: I'm sorry I didn't get, I wasn't able to get over here this weekend. The, ah, um, I told you I would. You still, did they give you my business card or is it still in your, ok; so you got it?

A: (inaudible)

Q: ok

A: Yes Sir

Q: I wasn't sure if you tired callin' me or not 'cuz this weekend they, ah, they put me on an airplane and I went out to Washington

A: Yes Sir

Q: I just got back first thing this morning. And, ah, some things came up that I wanted to come and talk to you about.

A: Yes Sir

Q: 'kay? But, um, obviously, you're here on, on the assault charge for Corey but, so before I talk to you about

A: but what (indiscernible)

Q: well be..., before I talk to you

A: (indiscernible) three of four 'cuz pe..., people are tellin' me it's three then something (indiscernible) it's four so which one is it?

Q: right

A: which one is it?

Q: well, before I can answer that question for you because you're in custody on that charge, ok, we need to read you your rights just, just so you're aware of those and then I can ask any questions that you have for me, ok?

A: (indiscernible)

Q: about

A: about the Assault Three and the Four (indiscernible), you have questions for me?

Q: well, but when I went out to Washington and stuff I talked to you, your wife and things like and, but, ah, before I can talk to you about the, the assault charges and ha..., that happened here and stuff 'cuz that's what you're in custody for

A: Yes Sir

Q: and before I can ask you questions or you ask me questions you need to be aware of your rights, ok?

A: How is my wife sir?

Q: well, like I said

A: I go to ask you that real quick before I cause (indiscernible) nothing criminal sir

Q: sure

A: how, how's my wife? Is she all right?

Q: she's fine

A: all right, that's, all right, that's all (indiscernible)

Q: so

B: m'kay, so, but you know this is a technicality we have to get through so just bear with me, ok? Ok, you have the right to remain silent. Anything you say can and will be used against in a court of law. You have the right to talk to a lawyer and have him present with your while you're being questioned. If you cannot afford to hire a lawyer, one will be appointed to represent you before any questioning, if you wish. You can decide at any time to exercise these rights and not answer any questions or make any statements. Ok, now I have to ask you these other questions, ok? Do you, have understand each of these rights that I've explained to you?

A: (inaudible)

B: yes? Ok, and having these rights in mind, do you wish to talk to us now?

A: what's it about?

B: well, it, unfortunately, because you're in here we have to do this before we can talk to you and answer any questions that you have, you know, Scott's already told you that he was in the Lower 48 and stuff and, you know, we just need to talk to you about everything involved here and so that's why we're, we have to do this 'cuz you're in here

A: so, so, so, so can I ask you a question then and you be honest with me? Do I, should I have a lawyer present when I answer these questions?

B: well this is what we can tell you. That, that's up to you. I, I can't make that decision for you 'cuz I'm a police officer, 'kay? But, you know it, again I, what I have to do is we have to get through this and, and, ah, havin' these rights in mind do you wish to talk to us now?

A: (indiscernible) I need to have my lawyer with me sir

B: you need to have a lawyer?

A: yes sir

B: ok, ok. Well, I, I'm sorry, then we can't answer any of your questions or say anything, ok? 'Cuz we want to make sure we don't violate your rights, all right? I mean that's, that's up to you so

A: I (indiscernible), if, it, if I, if I knew what was goin' on I would sit and talk to y'all but, but what you just told me I that anything that I say can and will be used against me against me in a court of law so, so, so (indiscernible) that doesn't make any sense for me to start talking before I would know what I was talkin' about

B: well, it, and I und..., I know what you're sayin'

A: I, I, I want to talk sir, and, you know, and I want to help you sir but I want to know, know (indiscernible) first sir before I can start givin' up my rights sir. I mean is, is that a problem sir?

B: ah, see this is not a problem for us, ok, and, and that's not an issue for us but, you know if, if, by law we have to advise you of your rights because you're in custody, obviously, you're sittin' here in the, in, in jail and so we have to read you your rights because if we're gonna talk to you about all of these things, including as, as Scott says we gonna talk to you about what happened with Corey and stuff because you're in here for that we need to talk to you and advise you of your rights first, that's all, and you know if, if you want a lawyer then, then that's your option. But we can't, you know we can't talk to you about

A: well, do I, do I, I need a lawyer? You guys, know because you guys are the detectives! You know if I need a lawyer or not

B: we can't tell you that (indiscernible)

A: I, I've been straight with you from, from, from the beginning Mr. Johnson

Q: all right, I

A: (indiscernible)

Q: and I appre...

A: (indiscernible)

Q: I appreciate that you've been straight up with me and like I said the, they flew me out to Washington

A: yes sir

Q: and because of that, ah, some other, well you know I talked to your wife and some other folks out there and I wanted to get your take on a couple of things

A: you talked to my dad too because, because, because somebody told me that my dad was callin' up here lookin' for me

Q: well you're, well, like I said I, I, I can't get into that unless you're willin' to talk to me, ok? But

A: I don't under..., it's just, it is all confusing right now so I, I, I don't know what to do sir

B: we understand that, you know we understand that, that you're confused and stuff 'cuz a lot of stuff has happened

A: because I'm (indiscernible)

B: in the last week

A: yes sir 'cuz I, I, I'm bein' truthful with you sir. I'm, I'm not a perfect person, a no, ah, nowhere near perfect but

Q: none of us are

A: but, but I, I'm not stupid either sir. And I'm the one who can't trust the, that I'm the one you all got behind jail so what, whatever's goin' on nine times out of ten the finger's gettin' pointed at me and, and, and, and I, and I just wanted to know if I need a lawyer (indiscernible) before I start talking (indiscernible)

Q: and I, I can't make it any more plain and simple to you, and I'm bein' straight up with you on, on this. I can't answer that for you

B: that's up to you

Q: you, you

B: you know?

Q: I mean you can do one of two things right now. If you want me to talk to you about things, which I'll be more than happy to do, Investigator Dahlke just read you your rights. If you want to waive those rights and you want to answer, you don't, I can ask you questions all day, you don't have to answer them. Ok? But in order for me to talk to you, you at least have to tell us that you understand your rights and that you're waiving those rights and it's ok for us to talk to you. If you don't, if you want an attorney here while we're talkin' to you, then we can't ask you questions and we really can't answer any questions that you might have for us. And I can't, I, I

A: so

Q: can't tell you that

A: so

Q: if you should have an attorney here or not

A: so

Q: (indiscernible)

A: (indiscernible) sir can I talk to you (indiscernible) because I, because I'm, I, I, I want to talk to you, sir, but (indiscernible). I really want talk to you. I plan for a, for a public defender, I should have him today so, but, but, but I (indiscernible), can y'all come back sometime today? (indiscernible)

B: hey, if, if that's what you want to do

A: (indiscernible) 'cuz that's, 'cuz I want to talk to you all

B: ok, because, you know

A: I have to, sir

B: if, just so you know, Scott and I, I mean we, we, we know whats happened, ok, we, we know that you were involved (indiscernible), 'kay, and we think that you got used and, and there's some issues (coughing), excuse me, and that's why we are here to talk to you 'cuz we wanted to get your side of the story, ok, because everybody's got their side of the story. That's why we're here. We're here to get your side of the story and understand what happened and what was goin' on in your life, you know that Scott has been down to Washington (indiscernible)

A: (indiscernible)

B: to talk to your wife and stuff so we, we know about everything that happened down in Washington

A: so what happened down in Washington?

B: well, and see, the problem is, is you, you, you want to get a lawyer go ahead and get your lawyer and we'll talk to you about those things after that because you've asked for a lawyer. Now if, if you want to talk to us briefly about it right now do you want to waive your rights right now? I'll read 'em to you again and make sure you understand, ok, and, and if you want to talk to us about it after that, you know, 'cuz remember at any time you can quit answerin' questions or making statements

A: but does that hurt me though sir(indiscernible) story of my life? I, I've never been accused of nothing like this sir, I, I don't know if I waive my rights if it is going to hurt me down the road or if it's gonna help me down the road sir. I, I have no idea.

B: and, and, honestly Jason, that's a question I can't give you my opinion on, ok? You're asking for our opinion as police officers, we're police officers, we can't give you our opinion on, on your rights. You, you have to make that choice. You want to talk to a lawyer and have a lawyer present while you're, while you're being questioned that's your option, 'kay? 'Cuz we, we have a lot of stuff that we want to talk to you about, obviously, right?

A: so

B: so

A: all right, so I, I, I got one more question but it's not, like a, about, you know, it, it, it, it's about if I do have a lawyer present I can't, does the, does the lawyer like know what you guys know?

B: no, he does not. He doesn't

A: so what's the purpose of havin' my lawyer even present then?

B: well what he's gonna do is your lawyer is gonna provide legal advise for you on you, whether you should answer questions. That's what (indiscernible) and, and I'll be honest with you, I mean if, if you're not gonna answer questions we're not gonna talk to you about this because it's a two way street

A: yeah, I know

B: you, you know? I mean you, you have questions, we have questions, we'll be fair to you as long as you're fair to us, you know? And, and we're not here to pull your chain, I mean you've talked to Scott, you know Scott. Scott's not gonna BS you, Scott's not lyin' to you. He's just gonna tell you straight up (indiscernible) the truth

A: (indiscernible) and (indiscernible)

B: you know, you, you know? And we're not gonna lie to you, 'kay, and we, we know what happened, ok? And we're willing to talk to you about it obviously, that's why we're here. You just have to make a choice whether you want to talk to us right now or not 'cuz it's up to you, it's your option, Jay you decide what you want to do

A: (indiscernible) I, I, I, I want to talk to you, I want to find out what happened but I don't know if you (indiscernible) happened, (indiscernible) what happened

Q: well, ah, obviously Jay this is, this is you're, you're involvement with us started on the 27<sup>th</sup>, ok?

A: (indiscernible)

Q: ok? When I contacted you at the airport, 'kay? From the point of contacting you at the airport till today I've been out in Washington, investigators around here have been working, so throughout our investigation we've come up with some things that we want to talk to you about. And like Investigator Dahlke was saying an area of concern for us is that we believe that you are possibly also a victim in this but before we can talk to you about that and get your take on that, 'kay, we (indiscernible) if you're willing to talk to us

A: (indiscernible) I don't know what to do

B: we, we can't give you legal advice, ok?

A: (indiscernible) I, I (indiscernible) I mean I know you guys aren't bad people but you (indiscernible) doin' your job regardless

B: yes we are, 'kay, and that's, that's our job

A: (indiscernible) and that's (indiscernible)

Q: well but see the thing is Jay we know you're (indiscernible) place, 'kay? There's little bits and pieces that need to be filled in. If you don't fill 'em in for us other people are gonna fill 'em in for you and I think you know the people I'm talkin' about. We think that this was a, that things kinda got outta control and that you're a victim here, and we want to know if we're right or wrong but like I said, before we can talk to you about that

A: (indiscernible)

B: (indiscernible)

Q: one of the reasons why I flew down to Washington, 'kay, was to locate Bill, and we found Bill and right now Bill is in jail, in custody in Washington so

A: (indiscernible) what about my wife? Is, is she, she's not in custody is she sir?

Q: that's one of the areas I wanted to talk to you about. Like I said we know

A: (indiscernible)

Q: but we know more than we're tellin' you. But like I said I, we, it's a two way

A: All right you come straight up with me sir, I, I, I coming straight up with you right now sir (indiscernible)

Q: 'kay, well, this is a two way street

A: (indiscernible)

Q: and I want to make sure

A: (indiscernible) you're not lyin' to me, are you?

Q: I'm not lyin' to you

B: no, we're not lyin' to you

Q: but I want to make sure that you understand that this is a two way street and you said that you might want a lawyer or you might not, but like I said, I'm bein' straight up with you, you be straight with us because if you want to talk to us and waive your rights I'm willin' to talk to you, kay? 'Cuz I really want to get your side of the story. I understand exactly what's goin' on, kay? So it's up to you. If you want to talk to us you let us know. If you want to waive your rights and talk to us right now I'm willin' to talk to you man to man right now, 'kay? And we can resolve some of these issues. But if you want an attorney then I can't, I can't talk to you now. It's your, your decision

A: I am going to trust you, I, I ain't trusted no one in my life (indiscernible) I looked into your eyes and it was like some reason god is telling me you can trust this guy right here

Q: you can trust me

A: I (indiscernible)

Q: I'm not

A: that's the only reason (indiscernible) I honestly feel in my heart man that you are really going to try (indiscernible)

Q: no, and, and I appreciate that 'cuz I'm really not, 'kay? We're just tryin' to get to the bottom of this

B: that's why we're here buddy, I mean that's what we're (indiscernible), 'kay? We just want to get it resolved, you know. Ah, I want to make sure, ok, so let me, let me read your rights to you so you'll totally understand, ok? Because we've had this conversation, all right? Ok Jay

A: (crying) I (indiscernible) baby (indiscernible) (sniffing/moan) oh my God ... I'll waive 'em (indiscernible), I'll waive 'em

B: ok. Let me, let me make sure, let, let me make sure we understand this, ok?

A: I understand you sir

B: ok

A: I'll waive 'em sir

B: then, then let me ask you these questions one more, one more time, ok? Do you understand each of the rights that I have explained to you?

A: yes, I, do you have me on a recorder sir? (indiscernible) recorder sir (indiscernible)?

Q: Jay, right now you're talkin' to Dahlke and myself

A: you don't have a recorder sir?

Q: well, you're talkin' to the police officers and you have no expecta..., I mean

A: (indiscernible)

Q: (indiscernible)

A: I am talking like about a tape recorder sir

B: here, I have a tape recorder

A: no, I'm just sayin' am I, am I on it?

B: it's not, look, it's not on

A: all right, I, I, I couldn't talk to you on the, on the recorder sir

Q: ok, all right

B: ok. Having these rights in mind do you wish to talk to us right now?

A: yes sir

B: ok

A: you guys ain't lying to me (indiscernible) that's (indiscernible) recording (indiscernible)?

B: here, here you go

A: I, I trust you scott, I trust you Scott (indiscernible)

Q: straight up, straight up

B: (clears throat) ok. We, I'll tell you what. We have a lot of questions for you, Scott's got a lot of questions for you (indiscernible) Washington. We know you're concerned about your wife, ok, and you know there's some r..., there's some issues with your wife, ok, I mean things, things don't look good, I'll be honest with you

A: who? For my wife?

B: yeah, 'cuz we think your wife's involved in this too

A: No sir

Q: Well but that

B: (indiscernible)

A: (indiscernible)

Q: ok, well tell us

B: (indiscernible)

A: No sir I'll, I'll, I'll tell you anything you want me to tell sir but

Q: ok, all right. Get, go ahead and start with what you know, what, what

A: (indiscernible), no, no, before we do anything like that sir

Q: ok

A: I want you to know that my wife had nothing to do with it

Q: 'kay

B: (indiscernible)

A: yeah, 'cuz my wife had nothing, nothin' to do with whatever it, (indiscernible), I don't even know what's going on but whatever went on my wife had nothing to do with it. My wife is a God fairing woman

Q: ok

A: she was just, she was listenin' to her husband

B: 'kay, so she was doin' what you told her to do?

A: she didn't, she didn't know nothin' sir

B: ok, and you I believe you Jay?

A: (indiscernible)

B: (indiscernible)

A: (indiscernible) sir, 'cuz that's the only thing I ask you sir don't put my wife away

Q: well I talk

A: that is all that I ask you is just don't

Q: I talked

A: don't put my wife in jail, that's all that I got to ask of you sir

Q: ah, I talked to her for about

A: I'm going to be one hundred percent cooperative (indiscernible) as long as 'cuz she's just a God fearin' woman sir, she

Q: well I, all right Jay. I talked to her for about three hours, she seemed like a very nice person

A: Sir she's, if, if you talked to her sir you know that

B: Scott had talked to her, I didn't

A: (indiscernible) she

B: (clears throat)

A: (indiscernible) she's blind to everything sir. If you talked to her sir, then, and then you know that sir

Q: the, the impression that I got from her was that she's a victim in this as well and she has been kinda led astray a little bit so

A: she didn't know, she didn't know anything sir

Q: 'kay

A: but that, if

Q: all right

A: I don't care about nothin' else sir except my wife sir

Q: 'kay

A: I, I don't care about nothin' sir

Q: 'kay

A: ex..., ex..., ex..., except my wife sir 'cuz she had nothin', nothing, if I die right now sir I, I, I don't care as long as my wife don't have nothin' to do with it sir

Q: I understand

A: but can you, can you promise me that right now sir?

Q: if

A: but if, if you said you talked to her sir

Q: I talked to her

A: (indiscernible)

Q: it, it depends on

A: I, I (indiscernible) percent, two hundred percent cooperative sir

Q: it depends, and don't take this the wrong way, it depends on what you tell me her involvement is or was not. I mean a lot of this, you know, I mean we know

B: it depends on what you tell us

Q: so want to start from the top about?

A: she wasn't involved at all sir

Q: ok, all right. Well, how are you involved?

A: I'd rather you ask that

Q: ok, um

A: (indiscernible)

B: and, and Jason that's fine, we understand

A: I don't know where to start (indiscernible)

B: ok, ok, and we know this is gonna be tough to talk about all right. And basically what we need to do is we need to talk to you about, and we're gonna back up to when those guys went down to make the score, ok? Because we, we need to talk about everything that happened, 'kay? And you came up to hang out with your buddies up here, Hakeem and, and Corey, right? And you came up for Christmas?

A: I came up before Christmas

B: you came up before Christmas? And we've talked about that before, we talked about when you got here probably about the sixth of December?

A:(indiscernible)

B: m'kay, and Hakeem and, and, ah, Bill Holmes, Zeke Holmes went down to the Lower 48. Were you with them when they went to Anchorage and got on the plane?

A: (indiscernible)

B: no? (clears throat) Ok, and so you go down, they go down to Anchorage, they get on a plane, they go to the Lower 48, and they go down to make a buy, and while they're down there Hakeem and Chris, did you know Chris?

A: no sir, I, I know

Q: I think I think they call him Big C?

A: I know of him sir but I don't know him (indiscernible), I, I, I mean basically (indiscernible)

Q: you, you knew who he was but you didn't hang with him?

A: yes, sir. I, It is just like I told you, I knew that he was like a big man (indiscernible)

Q: ok

A: but I, I was (indiscernible) they pushed me away, I was kind a glad they pushed

B: ok. Um, but they go down to make a deal, you're up here, you're here with Corey and Jackie and Teacka, right?

A: yes sir

B: all right. You actually were stayin' over there at that apartment where Teacka was living, weren't you?

A: I was, I was staying between, ah, Sleazy's, Sleazy's, ah, over there (indiscernible) and, ah, Hawk's

B: ok, and Sleazy is, is Corey?

A: yeah

B: yeah? Ok. I just was to make sure I got all your nicknames right, ok?

A: yes sir

B: 'cuz I know you guys called Hakeem "Hawk", right?

A: (indiscernible)

B: so, all right, so you were stayin' in between there and then last Friday is when all this started, for you up here? Now, we know that there was some communication between Bill and you, ok, and this is where we're a little concerned about your wife, 'kay, 'cuz you know Tr..., Scott went down and talked to her and, and you said that, that, ah, she wasn't involved and she was just doin' what you told her to do. Right?

A: yes sir. My wife, she's a God fearin' woman, sir

Q: 'kay

B: m'kay, and that's

A: if, if you two are married sir (indiscernible) a good woman

B: (indiscernible)

A: (indiscernible) a good woman doesn't ask any questions

Q: I understand

B: yep

A: she'll, she'll ask no questions

Q: all right

B: she was just doin' what you told her to do?

A: (indiscernible)

Q: m'kay, well she, what she did out there is important for me to understand what you told her to do. If she was just following your order what, what did you tell her to do on the phone? (pause) I mean did you tell her to go and pick Bill up?

A: I didn't tell her to go pick Bill up, I don't

Q: m'kay

A: (sobbing) That's my wife (indiscernible) (crying) my wife, my baby (indiscernible) (sobbing) my wife (indiscernible)

Q: ok

A: (crying)

B: Jay, Jay, we're not sayin' that she did do that

A: That's my wife sir, please lord, please sir

Q: I know

A: she's only 19 years old

Q: Jay, I'm just tryin' to figure out what, what you told her

A: (indiscernible) she, she (indiscernible)

B: did, did you just tell her to help Bill when he asked her to help him?

(pause)

A: (indiscernible)

B: ok, go ahead

A: I (indiscernible) (sniffing), oh God (indiscernible) I don't know (indiscernible) (crying). He said (indiscernible). Please (indiscernible) God, (indiscernible) she (indiscernible). Please dear God, (indiscernible) my wife (indiscernible)

... (pause) ... I want to talk sir, I want to talk sir, I want to talk sir about (indiscernible) I don't want my wife (indiscernible) for something that she did not know was going on sir (indiscernible)

Q: all right, well, we won't talk about your wife

A: that's (iniscernible), that's the whole deal sir

Q: 'kay

A: (indiscernible) I'm bein' honest with you sir. I've always been honest with you Scott

Q: and I, I appreciate it

A: and you've always been honest with me Scott

Q: I appreciate that

A: you can look in my eyes, sir

Q: I can

A: I, I have not reason to lie to you Scott. It's done Scott. I, I, I ask you please Scott, (indiscernible) I have no reason to lie to you Scott

Q: ok. Well let's, let's leave your wife out of this and let's talk about what happened on the 27th

A: (indiscernible) but I know about the law and I know that if I say that I told my wife to go and do anything, even if she didn't know sir, she's gonna be an accomplice sir

Q: not true

A: (indiscernible)

B: Jay

A: (indiscernible), I, I don't

B: Jay, listen to me

A: she didn't know anything sir. I don't want her to be an accomplice sir, she a young woman sir, she

B: and you, and Jay, you're sittin here and you're tellin' us that and we believe you, 'kay? So don't get us wrong, ok? If you're tellin' us your wife wasn't involved we believe you

A: she wasn't involved at all sir

B: if, then, then we don't need to talk about that if she wasn't involved. Ok? I mean Scott's talked to her, he, he met your wife, your wife's not in jail or anything, ok, and, and if, if you want to, let's just skip over that and forget it, ok? But we still need to talk to you about what happened on Friday and stuff, ok? So lets eliminate the phone call, 'kay, because she's down there, we're up here, 'kay, but you know what we want to talk to you about here, 'cuz we know what happened, 'kay? I'm not gonna lie to you Jay. Scott's not lyin' to you either, you know and I'm, I know you trust this man and I trust this man with my life

A: I trust you too sir

B: (indiscernible) you know where I'm comin' from?

A: (indiscernible) both of you all come to me with palms up sir, both of you come

B: and, and we

A: (indiscernible)

B: we appreciate that and we want you to understand that we respect you for talkin' to us, ok, because we know what happened and you know what happened, and we don't need to talk about what happened to Corey, 'kay? I mean, like, I'm not gonna beat around the bush with you buddy, you know that. You, you know it's over, we don't need to play any games, ok? We need to talk about what happened to Teacka and the reason why is 'cuz we know happened, we know what you did, 'kay? But, see, we think that there's a reason why you did it, and the reason why is this, because we know about your wife down there and Bill down there, 'kay, and what we think happened (indiscernible), what we think happened was you were coerced. You know what I mean by that, right? You were coerced into doin' this to Teacka because of your concerns about your wife down in Washington. And we think that's why it happened the way it did, because Scott's been down there, he saw them, he talked to them and we think that you were forced to do something you didn't necessarily want to do but you had to do it because we know how much you care for your wife and you're concerned about her welfare. And that's what we think happened and we need to know from you if that's the truth or not. You know 'cuz we don't think that you're, you're some kind of wild man goin' out on crazy binges doin' this stuff

A: no sir, I'm not, sir

B: ok

A: you can look at my record sir, it is all just little petty BS sir, it's stupid

Q: I mean your wife was pretty, pretty afraid of Bill and she was really glad to hear when she found out that Bill was locked up so

A: I know she was afraid of Bill, sir. I'll put it to you like this right now sir. I thought Bill was gonna kill my wife sir

B: well, that's what we figured

A: bottom line, point blank sir, I thought Bill was gonna kill my wife

Q: (indiscernible)

A: there was no way I could get down there to stop him (indiscernible) know what (indiscernible)

Q: that's what I thought

B: and did Bill tell you to do what you did?

A: yes sir

B: m'kay. Now did he tell you, because there's similarities with the exception of, of a few things, but there's similarities between what happened up here and what happened down there, 'kay, and what we figured was because there's those similarities, we figured Bill was talkin' to you and sayin' look, either you do this or, you know we figured your wife was in jeopardy

A: m'hmm, I'll tell you right now sir. He was, I don't even know sir, it was just (indiscernible). It's all (indiscernible) sir

B: we understand that

A: (crying) (indiscernible) mean for it to happen like this sir

B: well

A: I'm., I'm, I'm gonna be real with you on this 'cuz y'all been real with me, I gotta get it off my heart. I said my little prayers, Lord's gonna look out for me, the Lord's gonna look out for (indiscernible). Started way back on the last trip, I think it was like back in November sometime, this is my only second time bein' up here. Me and Bill were, like, like I told you all I, I went to high school up here

B: m'hmm

A: I've been gone for like seven years. I just now came back, back in November for the first time because I met ol' Hawk down in Washington and Hawk (indiscernible) there, and Hawk seen I was doin' bad so he was gonna put me onto some money, which was what you already know, which was movin' (indiscernible) from down there to up here

B: yeah

A: man! You couldn't see like this. It was, it was, when I, when I got up here in November Bill and Hawk had fell out about something, had fell out about dope and money or somethin' because I guess Hawk had put Bill on and Bill was makin' more money than Hawk so Hawk didn't like it so Hawk had cut him off and then, and I, and then I guess Bill was talking about that. Anyways, so just to keep, I'm not even gonna say to make a long story short 'cuz it is a long story so it'll be long, anyway, so this is everything I know sir, I am spilling it all out to you right now sir. And I'm a loyal person sir, (indiscernible) I'm, I'm very loyal but I done betrayed everybody, I, I betrayed

everybody. I can't even say I'm scared of Bill sir 'cuz I was not scared of Bill sir. It was just that he had me between a rock and a hard spot sir

Q: I understand, yes he did

A: I, I'm, I'm, I'm not, I don't fear no man sir. He had me between a rock and a hard spot. Really, to tell you the truth, if, if I probably wouldn't a been married none of this woulda happened 'cuz I, I woulda been, I, I would of blew him off like you're crazy

Q: I understand

A: this had all happened too fast sir. I'm gonna put it to you like this sir. So, the first time I was up here and I (indiscernible) how he fell out about all that stuff, ok, (indiscernible), I'm, I'm, I'm tryin', I'm tryin' to give you everything, and after they fell out about all that stuff sir, ah, (pause) Hawk had left about, like, I say it was, I don't remem..., I don't know the exact dates but y'all's the investigators so I'm pretty sure that y'all go down to the airport or, or wherever y'all do that (indiscernible) and they'll give you exact dates when I left and came and all that so I'll give you (indiscernible) the dates which Ha..., Hawk had (indiscernible). But (sniffle) I know Hawk had left sometime in November to, ah, to go (indiscernible) to go get some dope. Again, basically sir, it was like this. When Hawk had left I don't know, somehow sir, some, the deal was different sir. Hawk, Hawk had Bill different, and I, I, don't know, as soon as Hawk left and some how Bill, like, slid his way back in there and with me it, it was just me and Bill, out at the spot. W..., it was like two days where just me and him all, all by ourselves and he was just, and, and the, he was just working on me sir Bill was just working on me. He told me oh, you, you, you this, Hawk that, Hawk ain't about shit (indiscernible) he was workin' on, he'd just try to get me to turn my back on Hawk 'cuz he didn't like what Hawk did to him. And then I told him, I, I, I, I, I told him, I was like, the first time, 'cuz he wanted to do it a long time ago, first time Hawk had came up there with a key. That's what he wanted to do with, do with the key. I don't know but I just told him like, man, that that's not true. So, so Bill like

B: (clears throat)

A: Hawk, I was down in Washington with, with, ah, Hawk. When we, when Hawk had gotten the key and the key was at my house and Bill wanted me to call him and tell him, and tell him when it got there 'cuz he would come down and, to do whatever he does but, I don't know, I just, I'm, I'm just not a bad person, just like my mom always told me, whatever, whatever goes on Jason deep down you've got a good heart. And, and that's what my mom always told me, when you (indiscernible), (indiscernible), she said no matter what I'd, I'd be (indiscernible) with all the stuff and my mom would come to me and say you got a good heart. And I'd guess that's what it came back to 'cuz when Bill called me, called, called down there, he asked me if I had it and I told him no. And I was sitting there looking at it like (indiscernible), because the first thing I thought about was, we..., when I was out there struggling, who put food in my mouth...It, it might've been illegal but Hawk put food in my mouth, Hawk took (indiscernible) of my wife. So I told y'all's like no, man, he, he, he only got like two, two ounces or something. I was just lyin' to him 'cuz I knew that if I told him that he got it that he woulda, that he woulda made somebody's time (indiscernible) lyin' to him. Turns out it he lied (indiscernible). So then I didn't see, I didn't see Hawk had (indiscernible) close again so Hawk had came back up here so the second time that I had came back up here after Hawk Bill's on my case like *why'd you lie to me (indiscernible)? Why'd you lie to me? Hawk showed me this and*

Hawk showed me that, man why'd you lie to me (indiscernible)? Man, why'd you lie to me? I'm like man, so Hawk, he said (indiscernible), I'm like man I'll, Hawk didn't show me what he showed you, Hawk just showed me this man. I'm tellin' you man, I, I didn't know he had it lie that

B: (clears throat)

A: so then "F", he's like nah., " F" that, "F", "F" that, next time (indiscernible) and basically he just like (indiscernible) him. I didn't believe him. I'm gonna be in jail for the rest of my life (indiscernible)

Q: (indiscernible)

B: Jay, we're not, we, we can't say that 'cuz we don't know. Every..., everything that you talked about today though I can tell you this

A: so are you guys gonna help me out?

Q: ah, Jay

B: I'll tell you this

A: (indiscernible) are, are, are you gonna (indiscernible)

Q: you, you, you said it yourself. You have a good heart, and I know you have a good heart because you're talking to us right now and you're trying to get this off your chest and I, I appreciate that. A, a man

A: (indiscernible)

Q: only has his word

A: (indiscernible)

Q: that's all a man has, and you are one hundred percent a man

A: if you

Q: and I

A: there are, you know Scott (indiscernible)

B: well let me tell you this

A: give me one last chance to make it right, sir to get out

B: Jay

A: yeah, (indiscernible) to see my wife sir. I don't care if I gotta do ten years sir but this, give me a chance to get out (indiscernible)

Q: well

A: to get one more chance sir

Q: well let me, keep goin' with what you're telling me

A: (crying) (indiscernible)

Q: Jay, Jay

A: (sobbing)

Q: I understand but Jay, look at

A: (sobbing) (indiscernible) (crying), (indiscernible)

(rustling sounds)

B: Jay, let me, let me help you (indiscernible). I just want you to know that

A: you can't (indiscernible) you have to help me sir

B: Jay let me tell you this

Q: We'll try

A: (indiscernible) if you guys can't help sir (indiscernible)

B: I will raise my hand and I will say in a court of law in front of God and everybody that you were straight up, forward and honest with us and, and you weren't a liar, you, you're not a running dog or nothin' and you just told us the truth about what happened. And that's why I can promise you, I can promise you that we will tell them that, that you didn't lie to us, you told us the truth, you were straight forward and you were honest. And because, Jay, that's what's gonna help you, and you know that, you know?

A: well, this is not me sir. I hope that y'all can see that (indiscernible)

B: and, and Jay

Q: you know I can

B: you know I, Scott and I are sittin' here

A: this, this is not me sir

B: and there, it, it's obvious

Q: I understand

B: to us that this

A: (indiscernible) sir

B: that you got, you got caught up in somethin'

A: that's all I did sir (vomiting sounds) (indiscernible)

Q: well Jay, the big thing, the mitigating fact of the matter is, is you have Bill and you know what Bill's capable of doin' and he's sitting down in Tacoma

B: and he's already done it

Q: with your wife and he's tellin' you that you need to do this

A: that's what he told me, he said I didn't ev..., that the only thing that was goin' through my mind was that I'm gonna get a call from my dad sayin' that your wife has been killed...is because I, I, I, I didn't do what he told me to do

Q: I understand that

B: and Jay, he, did he tell you to kill Corey and Jackie too?

A: he told me to kill everybody sir

B: he told you to kill everybody?

A: I, I couldn't do it though sir. I (indiscernible) I, I couldn't do it. I tried but I couldn't do it

B: you know, and Jay, Scott and I knew that. We knew in your heart because Corey was your friend

A: yeah, I, I couldn't do it

B: and you couldn't do it. But we also understand why you killed Teacka, 'kay, and you, we understand you killed her because of Bill down there with your wife, and we know that. And that's why we're here to talk to you and we're bein' honest and open with you because we know that you have had no choice in killing Teacka

A: what

Q: I'm sayin'

A: I, I'm not gonna lie sir. I though it was all...I, I didn't think Bill was capable of it sir, to tell you the truth sir. I thought is was just all BS sir. You know how people talk

B: yeah, talk (indiscernible)

A: talk a big game and

B: oh yeah, talk it, talk the talk. We know that

A: until when he put in my pager, 'cuz he put in my pager, he say he was gonna put it, he, he was gonna page me and put in his code and put it in a way sayin' that he just did it. And then that means I gotta do what I gotta do. And he put that in my pager Christmas eve. I just couldn't do it. I, I was supposed to do it that, the moment when he put it in my pager but I just couldn't do it. It took me like three days to just even get up to tryin' to do it. (indiscernible) (sigh), we'll get back to the story sir.

B: go ahead

A: anyway, when I got back up here sir Bill had somehow worked his way back in with Hawk and Hawk didn't know. I was gonna tell Hawk sir that, you know this, that Bill was not all there, Bill, but I, I didn't know if it was true or not. I didn't know it he was just

B: talkin'?

A: yeah sir

B: (clears throat)

A: somethin' told me to tell Hawk but I didn't do it and now this is what happened because I didn't tell Hawk. But I was a very loyal person and it just kills me on the inside that I betrayed him like that. 'Cuz Hawk put food in my mouth, he put food in me and my wife's mouth when, when we had nothin'. And it wasn't even supposed to happen like this sir

Q: I understand

A: it was not supposed to happen like this

B: and Jay you know I, I think on a, a, correct me if I, 'cuz I understand, I, I think I truly understand now how, what position you were in because Bill put you in this position because two things. One, you didn't think Bill was gonna do it, did you?

A: no sir, I never did think that he was gonna do it

B: and, and then when you realized

A: when, when I got that page I realized that he did it

B: is that when you knew that your wife was in danger?

A: that's when I knew my wife was in danger, that's when I knew that he was sittin' on the couch next to my wife and at any moment if I didn't follow orders and he do, do the same thing to my wife that he did to, ah, Hawk and Big C

B: m'hmm

A: and I love my wife too much

Q: I understand

3823

A: I, I'd rather give, I, I would rather give my life then, then, (indiscernible) then, then, and then (indiscernible), then for my wife to die

B: and we understand that

A: that's all I ask you sir is that you just, I don't even care about me sir 'cuz I, I'm a, I'm a grown man sir, I'm (indiscernible) up with my actions sir. I mean ev..., even though the whole situation surrounding this sir was all messed up sir but

Q: the

A: but my wife sir, please sir

Q: we understand

A: my wife had nothin' to do with it

Q: Jay, but, but

B: we understand that Jay

Q: Jay but

B: we do

Q: he burnt the car down there. Did he tell you to burn the houses up here?

A: he told me to burn it so there would be no fingerprints or nothing

Q: 'kay, so that's why you burned, what was it, 3210 Parks where Teacka was? 'Kay. Did he tell you how to kill Teacka? I mean did he want it done a certain way for payback or, or did he just tell you just to do it?

A: (indiscernible) He just told me to do it, so I did it. Those were his exact words

B: did he, well, and

Q: ah

B: the reason why Scott's asking is, is did he tell you to kill her with the hammer or what did he tell you to do? Did he tell you shoot her or, obviously he hated her, right? And did he tell you to do it, do it with a hammer or what did he tell you to do?

A: he said, he didn't say, he just, he just said do it

B: he just told you to do it? M'kay

Q: well, she had some head trauma. Did he tell her, basically to beat her head in?

A: (crying) (indiscernible), oh, my God (indiscernible), oh  
(rustling sounds)

B: I know this it really hard to talk about

A: I trust you guys, I trust you guys. The whole reason why I'm talkin' to you guys now is please, please you guys, you gotta help me, I trust you guys

Q: well, like I said

A: you guys gotta help me and my wife. I trust you guys. I know I've got

B: 'kay

A: to be responsible for my actions, sir

Q: I understand that

A: I know that sir

Q: but I know why you did what you did and I underst..., I understand what you did and why you did it. That's the big thing, 'kay? I mean that, that says a lot about your character and you're not just out doin' this because

A: no sir

Q: you wanted to do it. You're doin' it because you were afraid that Bill was gonna kill your wife if you don't kill Teacka

A: you

Q: I mean is that correct?

A: yes sir, I mean it, it was just the whole point that he was at my house sir

B: and he was

Q: something that you're

B: (indiscernible)

A: that's why

B: (clears throat)

Q: Jay

A: that's why I told her I, I'm not gonna tell you nothin'

Q: right

A: 'cuz I, because, because it's crazy sir but I'm (indiscernible)

Q: somethin' that, that's, that's gonna be important for, for Teacka's family is that they know that she didn't suffer. I mean was she asleep when it happened or how did that, how did that whole thing go down? Do you remember?

A: I wasn't even involved. I was, it wasn't me sir, it was not me sir

Q: right and you were out of your mind at the time, I understand

A: it's was just like, it was just like with Corey sir, it was, it, it, it wasn't me. Between Corey he just grabbed me and he said, "it's me! It's Corey!" It was like I snapped and I just (indiscernible) dropped to my knees and started crying but

Q: but

A: it wasn't me

Q: right and that was after that Teacka had been killed?

A: it wasn't me, it was not me

A: it was not me at all, it was not me

Q: and so when, when you said that

A: I couldn't do it

Q: when you said that to Jason, er, not, I'm sorry, when you said that to Corey that you didn't know what you were doing, things like that, that was just tryin' to cover up so he wouldn't know what you were tryin' to do to him? Is that correct?

A: I didn't know what I was doin' sir

B: Jay, and we're just trying to clear things up 'cuz we understand why you did what you did, ok, and it's probably a good thing that Scott went down there because your wife's alive and, and free because of that, because we figured this out

Q: absolutely

A: well when you went down to my house Bill was in my house wasn't he, sir?

Q: Bill was driving your car around and he had been at your house earlier and he was on his way back to your house when we stopped him

A: Who, WSP?(indiscernible)?

Q: Tacoma, Tacoma Police, myself and then the California authorities. The California guys are investigating Hawk and Chris

Q: 'cuz they, their bodies were dumped on I-5 in California. So we went over to your house and we were watching your house and he showed up at your house and that's where he was taken down so

Q: Sincere is her name?

A: yeah, (indiscernible), yeah, Sincere (indiscernible)

Q: beautiful little girl and I feel fortunate, as should you, that, that luckily we got there in time because I don't know if Bill wouldn't have done something anyway and then maybe turned on you

A: sir, I'm goin' to tell you right now, sir, he would have sir. I know he would've, sir

Q: and

A: deep in my heart I know he would've

Q: and I, I bet you

A: if he would've found out that I didn't hold up my end of the deal, sir

Q: m'hmm

A: he would kill my wife, sir

Q: yeah

A: that's, it sounds stupid sir, but I'm glad, sir, I'm glad I'm in here in locked up right now, sir

Q: yeah

A: I, I thank God that I'm in here locked up. I thank God that y'all got me at the airport when you all did sir, 'cuz who knows, sir He could've (indiscernible) to ambush me, soon as I got off the plane, who knows, anything

Q: I think that

B: that's a possibility

Q: that's, yeah, I think that's a very high a probability

A: could, I don't know, I, I, I think, Bill has told me once before that he's the type of person that he's gonna leave the whole thing that, ah, he's just not gonna be able to say, oh, Bill did it. He's said he's gonna leave it to where it's gonna be a whole bunch of people dead

A: I couldn't do

Q: there's nothing but good they do?

A: yeah, Jackie was like my wife as far as like, like what was goin' on, she was like

Q: yeah

A: (indiscernible) everything

Q: right. What, now what exactly caused the injury the Corey's neck? I mean

B: (indiscernible)

Q: I mean did you try to stab him and then it just, it didn't happen, it didn't work and then he started to struggle with you and that's when you just, he said hey, it's me, it's me? That's when you just broke down and lost it? Was it a kitchen knife or

A: (inaudible)

Q: 'kay

B: and, and Jay, you know, I know this is hard to talk about but, ah, we need to talk to you a little more about Teacka to get that part cleaned up. And, hey, we know, I'm sorry, go ahead Scott

Q: I'm dry. Do you want some water?

A: (indiscernible) Scott, (indiscernible)

Q: ok

A: (indiscernible) shackled

Q: let me get him in here. You don't need to be wearing those. You're being a good guy. But I'm, do you want water? Water?

A: he was just, just basically, basically, af..., after he, he put in my code every day af..., after he paged me he would call the Spot and disguise his voice and Teacka would be like somebody called here for you with this disguised voice but they hung up

Q: 'kay

3831

A: so to me he was just, keep on calling and checking to see if I did it

Q: right

Q: did you, did you actually talk to him actually on the phone, at any time after he killed Hawk? And did he, did he specifically tell you, hey, I shot 'em in the head and then I bumped 'em or what did he say to you?

A: he didn't say that he shot them in the head, he said (indiscernible) just dead ... God, it's crazy!

Q: right

A: (indiscernible) those were his exact words, I, and to me this is what, this is what made me do it right it here, is this, is, is, is when he said this right here, "yeah, yeah, yeah, your boy did it, your boy did it. They, they won't see Christmas." That's when the, I told you he said that was like somethin' strange (indiscernible) comin' over me, like, the guy's not playin', and he said "your boy did it," and he, liked, laughed and said yeah, they won't see Christmas

Q: 'kay

A: see he (indiscernible) won't see Christmas?

Q: m'hmm

B: that's really sad

Q: yeah, that is pretty disturbed

A: and when I told him some, some, (indiscernible) right there, I was just, that's my wife in my head like, this guy is gonna kill my wife if I don't, if, if I don't do somethin'. Not even just, if I don't do what he tells me to do, if I don't find a way to get to him before he gets to my wife

Q: m'hmm, did you ever call him up on the 27<sup>th</sup> after, after Teacka was killed and after Corey was stabbed? Did you ever call him up and say hey, my, I'm done here too?

A: huh ah

Q: never did? 'Kay

A: well, I, I wasn't, I (indiscernible) idea, I (indiscernible)

Q: well, but I mean

A: (indiscernible) I didn't know (indiscernible)

B: sure

Q: just, just being concerned for your wife I, but before we contacted you, I mean did you email him or page him back tellin' him that hey, I did it

A: I just

Q: so your wife wouldn't get hurt?

A: I just knew that if I got there, I talked to my wife, I didn't talk to him, I talked to my wife, that's how I knew that she was all right

Q: all right, ok, that makes sense

A: I talked to my wife and I told my wife (indiscernible)

Q: all right

A: (indiscernible) was gonna be there

3832

Q: all right. So you didn't really change your plane tickets to get out of Fairbanks because you killed Teacka and more so that you wanted to get back to your wife ASAP and make sure that Bill didn't do anything to her

A: I got my plane ticket way before any of that happened, I told my wife that I, I, I, I told my wife I was, like, I don't know, sir, it, it was like I felt if

Q: right

A: it was, it was you know that you're not supposed to be doin' nothin', it, it was like God was on my shoulder like you know this ain't gonna turn out right, right? No, it's not gonna turn out right

Q: all right, 'cuz you could, you actually changed, or your wife, you had your wife change your plane to (indiscernible) on the 23<sup>rd</sup> or something, right, come back on the 27<sup>th</sup>? I think that's what we found out down there talking to your wife? She said she took some money from the blue bag in the closet, she said that's where she hides her money from you so you can't spend it (chuckle)

A: yeah

Q: and that she bought the plane ticket for you to come back on the 27<sup>th</sup> 'cuz she wanted you to come right home so, ok, but that makes sense, makes sense. That makes sense

A: so what do, what, what all

B: let me ask you one quick question or, um, actually, two quick questions. Um, the, the fire, you started out with the gas in the back of the truck ... yeah?

A: he told me to do it, that was Bill's truck

B: and, and see that's what we thought

A: and Bill told me he said the gas is in the back of my truck and he, he told me it is already filled up, which is (indiscernible)

B: 'kay, is that that little gas can that's sitting in the back of the truck?

A: there was two of 'em, yeah

B: there was two of 'em in there?

A: I left it in the house

B: left it in the house?

A: yeah

Q: did

B: did

Q: do you remember the fire comin' at you and rollin' over your hat? 'Cuz your hat was all singed

B: it burned your hat a little

Q: did you get burnt at all?

A: (indiscernible)

Q: well, I

B: burned your lips?

Q: are you ok?

A: (indiscernible), yeah, I, I, I'm fine, just

3833

B: did it burn your hands?

A: got one of 'em

B: can I, can I see it? (indiscernible), oh yeah. Oh, you got burned pretty good

A: I didn't know what I was doin', sir, it just

Q: were you actually standin' on the inside, inside the apartment when you lit it?

A: yeah

Q: with fire comin' all around you?

A: all the way around me. I thought I was gonna die. I didn't, (indiscernible), I didn't know what I was doin'

Q: right

A: I didn't know, I didn't even, I didn't know the first, to begin at about lightin' a house on fire, I didn't know if he (indiscernible) gasoline in the back of the truck, (indiscernible), he told me to pour it into, he told me to dump it all over the place and then, and then light it up. He didn't tell me to go outside first or nothin'

Q: did you actually dump the gas all over Teacka top? Right where she was layin'?

A: I dumped gas over her. I don't

Q: 'kay

A: remember if I actually dumped it on her but I know that it, I dumped gas on the whole house

Q: ok, 'kay. But you didn't use a gun or anything like that on Teacka? It was just, just the hammer?

A: I used (indiscernible)

Q: 'kay, a knife or just, just the hammer?

A: I didn't, I didn't do it, sir

Q: all right, well, the person that did it

A: what was I thinkin' about! Oh my God! Please Lord!

Q: so then when you left in the truck where'd you go in, in the truck after you left?

A: I wasn't in the truck

Q: you weren't drivin' Bill's truck when you left the fire? What were you drivin' the?

A: I was drivin' the, ah, drivin' a car

Q: the, the tan Kia?

A: (inaudible)

Q: ok

B: did you move the truck from over by Corey apartment to the backside of the apartment?

A: no, the truck was there, it, it was just, I was just, (indiscernible) it was one of.... jobs was to start the truck just keep it running, ah, (indiscernible) had no plug ins

B: 'kay

A: so every two or three days I would start it up and drive it around the block

Q: ok, and, and, so at what point in time you parked it from in front of the apartment to the other side?

A: (inaudible)

Q: ok

3834

B: so when you left the hospital you went over and got the gas can out of the back of the truck? Is that how the gas can, how you got the gas can over to Teacka's apartment? Or did you have it in the Kia before you guys went to the hospital?

(pause)

A: I feel so bad sayin' "I". I don't feel like "I" did it. (indiscernible) that, that was nothin' (indiscernible), that was nothin' (indiscernible). I (indiscernible), that's why I feel so bad sayin' "I"

Q: well don't say "I", say

B: just tell us what just happened

Q: 'kay

B: the gas can was in the car (indiscernible)

A: (indiscernible), sir, you can ask my mom, you can ask my, you can ask anybody that lives around me. I'm, I did not do this

B: Jason, we don't think that, you know, I mean you've heard Scott and I say this, you know, we, we don't think bad of you 'cuz what, what happened

Q: I can't say that if I was in your same position I, I have done the same thing. Bill has basically your wife

B: and we knew, we knew that's what it was, that's why we came to talk to you about it (clears throat) you know, and, but you know and, and I'm sorry, Jay, that I gotta ask you these things but I'm just trying to clear this up, ok, because there's other people that have questions too. We, like Scott said, you know, and the, and I mean when you killed Teacka, you know, their fam..., her family is askin' did she die quickly and we just want to make that that, that that happened. I mean was she sleepin' on that mattress?

A: I had my eyes closed

B: you had your eyes closed when you hit her?

A: I had, yeah, the first time I had to close my eyes and that's it

Q: well, was she layin' down when you first hit her or was she standin' up?

A: she was layin' down and I had my eyes closed

Q: ok, so she was probably asleep

A: I didn't, I didn't, I didn't want to look at her, sir, 'cuz it was, it, it, it wasn't me doin' it, I was just, ah, I don't even know, sir! It, it's hard to explain, it's very hard to explain, sir. I thought I was in a rock and a hard spot, (indiscernible). You got two options, you got option one

Q: neither one of 'em are good

A: neither one of 'em are good, sir

Q: lesser of two evils

A: it was

Q: I understand

A: two wrongs don't make a right but it was, I don't know, (indiscernible)

B: can I ask you where you left the gas can in the apartment? Did you leave it over by her?

A: I don't know, sir

3835

B: you don't remember?

A: it just, I, I'm not, I'm not a professional at this, sir, I just took my orders and

B: and, and we understand that. You were just taking orders

A: I didn't

B: you're being

A: I, I didn't know

B: (indiscernible)

A: to tell you the truth, sir, but what I, but what I lit it, I, I scared myself because I, I didn't even think it was gonna (indiscernible), it's so (indiscernible), it, it seemed to me like the whole place just blew up

B: so did, was a there a big boom or

A: (inaudible)

B: there was:

Q: did you get knock to the floor?

A: I thought I was gonna die and I ran out

Q: that would be pretty scary

A: it was incredible, I mean I didn't know what I was doin'. It was obvious I didn't know what I was doin', I was, it was

B: ok

A: follow directions, I couldn't even follow, it was like (indiscernible) directions I was following (indiscernible)

Q: well, when you left in the Kia where did you go to?

B: after you left the fire

Q: when you left the fire

A: to the hospital

Q: to the hospital? The, and I, I don't know why, ah, but the, they're really interested in finding the hammer. You have any idea where you threw it so we can go look for it? I mean they're gonna make me go look for it

A: I, I (indiscernible), sir

Q: and I'm gonna be traipsing around, it's 30 below zero right now

A: I know, sir

Q: do you

A: (indiscernible) lookin' for it 'cuz that's part of the case

Q: can you

A: and you have to have it

Q: can you pin it down, narrow it down for me?

A: I just (indiscernible)

Q: but how far?

A: 'bout, I'd say about ... three, three to five miles

3836

Q: 'kay, you went past the scale house there? You know where, when you go towards Anchorage just a little ways down the road you got that

B: from the apartment (indiscernible)

Q: from the apartment

B: (indiscernible) curve (indiscernible)

Q: you know where Ester is?

B: (indiscernible)

Q: the way station, you go up the big hill? And you're goin' up the big long hill on the way to Anchorage?

A: I was goin' the other way

Q: ok, so you were goin' towards

A: towards Anchorage

Q: yeah, that's, that's towards Anchorage

A: I thought you were goin' up the big hill comin' back to Fairbanks

B: well, there's a hill on both sides

Q: yeah, I'm sorry, there's a hill on both sides. If you went out and turned right, you went around a big corner and then you would start to go up some

B: it's a real long hill

Q: long, couple miles long

A: I, yeah, I probably (indiscernible) hill but

Q: did you, did you

A: it was somewhere in there

Q: did you pull out at the pullout at all or?

A: I stopped on the side of the road

B: stopped on the side of the road

Q: did you throw it on the right hand side or on the left-hand side?

A: if you're drivin' towards Anchorage on the right hand side

Q: so you pulled over to the right hand side, got out

A: the, yeah, right side of the, the, the side of the road I was on. I pulled over

Q: did you just get out and throw it from there?

A: (indiscernible)

Q: or did you walk off the road

A: I threw it from there

B: and, let me ask you a question, what color was the handle on this hammer? Do you remember?

A: I can't say I, I remember

B: do you remember if it was yellow or black or?

A: I don't remember, sir

B: was it a shiny colored hammer? Like silver, did it look like silver?

3837

A: it looked, it looked, it looked like a hammer to me. 1

B: ok

A: I wasn't

Q: I

B: well

A: I wasn't in

B: it's been described

A: my right mind

B: to us so

A: and that's why

B: we understand

Q: how far do you think it went in the woods? Did you see where it, it landed, I mean, or did it just take off and go?

A: I just

B: chucked it and left?

Q: it, was it hill that was goin' up where those woods that you threw it into or did you throw it down a hill?

A: it was straight (indiscernible) into the woods

Q: 'kay, anything else right in that area that you can remember that might help me pin it down a little bit? A sign, a road sign, guardrail right there at that area where you pulled over?

A: (indiscernible)

Q: there's some guardrail there?

A: on the right (indiscernible) guardrail

Q: was there kinda like a little valley, a depression there? There's a guardrail

A: there was, yeah

Q: hmm

A: it was a black (indiscernible) but I could see trees there

Q: yeah, there's little trees, there's like shrub trees. There's not a bunch of huge, huge big trees, I mean there's, there's trees but it's kinds clear in this little valley?

A: it was hard to see. I just know that I was, it was by a guardrail and I threw it and that was it

Q: ok, well, that, that, that'll help me a little bit (indiscernible)

A: (indiscernible)

B: Jay, I (indiscernible), there's one other thing I gotta ask you, it's about your clothes, the clothes that you were wearin' when that, when all this happened. Where are those clothes now?

A: the clothes, I put 'em in the dumpster

B: do you know which dumpster?

A: it's out there at Goldhill

B: at Goldhill Liquor?

A: yes, sir

3838



B: m'kay, so you stopped there at the gas station and the liquor store?

A: Bill, Bill told me to burn the clothes but the way it all happened I almost died myself so I couldn't

Q: you weren't gonna stay there

A: yes, sir

Q: I understand that

A: it, it was just, basically I was followin', I was followin' somebody else's plans. It just didn't, it just didn't

B: you just did what you were told to do

A: it just didn't work out right

Q: did Bill, did Bill put these plans in writing or just, is this just what he told you verbally?

A: he never put nothin' in writin'

Q: uh huh, ok, everything was just over the phone?

A: (inaudible)

Q: 'kay. How long ago did he tell you to do this? I mean in this type of a detail he wanted you to burn, burn the house and the body, burn the clothes, how, it, it, and this happened on the 27<sup>th</sup>, when did he tell you that you needed to do this? Do you remember?

A: so what, what, what do you mean? I don't understand what

B: what, what he's asking is this is when Bill said ok, I'm gonna kill these guys, I want you to kill Corey and Jacquie and Teacka

A: and he wanted me to kill whatchacallit too, Killer, he wanted me to kill Killer too

Q: do you know who that is?

B: Keyes?

A: yeah

B: Mike Keyes?

A: he wanted me to kill Killer

B: he wanted you to kill Killer too. Ok, well, when did he tell you

A: I, I couldn't do it

B: to do that, that's what he wanted you to do, was it before he left to go down? Ok, do it's before he, so he told you first

A: it's so, it was just, the whole, he, he told me, he was just like, he, he said

B: this is what I want you to do?

A: this is what I want you to do so I figured when I, or when I page you, he, he told me as soon as he gives the page carry out the plan, but I couldn't do it. It took me at least three days later before I could even

Q: do you remember when that was when he told you? Was that when the two of you were alone in the apartment for those two days?

A: that was back in November

Q: ok, so he told you to, to do this in November then?

A: he told me, he gave me, like, he gave me like the rundown, either he told me to keep all of that until like the day before he left

Q: 'kay, and then he said that he was gonna, page you, did he tell you what he was plannin' on doin' with the Hawk and with Chris?

A: he just said, he just, he didn't, he told me, he told me that he didn't want me to know what he was gonna do with them, but I heard from somebody down in Washington that, that sounds like Hawk was gunned down in the back or something, it, I don't even know but, but that's what, so somebody said that Hawk was gunned down in the back and, ah, I don't even know what happened to Big C. It was, so what happened to Big C?

Q: same thing

A: was he gunned down in the back too?

Q: yep

(pause)

B: Jay, um, (indiscernible), 'kay? Did he talk to you about the money at all? Did he, did he say anything about givin' you some money or

A: 'cuz that's another thing right there. I mean (indiscernible) my wife's life, because, because, as soon as he said, as soon as he said, ah, they're not gonna see Christmas he was, like, uh, they didn't, he, he said somethin' about that they didn't have what he was expectin'

Q: hmm

A: so that made me think that the plan wasn't right so, therefore, somethin' was wrong. And that's another thing that made me think my wife was in danger. So he didn't get what he said that he was gonna get

B: sure

Q: yeah, yeah, understandable.

Q: I would have been concerned to

A: (indiscernible) Like I said, I was not scared of (indiscernible), I knew he couldn't get me (indiscernible) friend

Q: you weren't scared for you, you were scared for your wife

A: my wife, yeah, me, I am a grown man sir, and, and you know how it is to have...(indiscernible) another man just can't kind of like put that kind of fear in you

Q: sure

A: (indiscernible) when somebody that you know is weaker

Q: kids, wives

A: yeah, it (indiscernible) like, I wasn't scared but that was my wife though so basically I was scared

Q: understandable

Q: the rings that you had, were those Teacka's rings?

A: no those were uh... those were Kathy's rings

Q: Kathy? Who is Kathy?

A: (indiscernible) a smoker, I don't want to bring no uh, I don't want to bring nothing on her, (indiscernible) she doesn't know anything (indiscernible)

3840

Q: she doesn't know anything about this

B: so you hooked up with her

Q: ok

A: yeah, I.. yeah, I, you know, (indiscernible) sell drugs and somebody doesn't have enough money they give you collateral and that is basically what that was

Q: that's what that was, ok

A: that was nothing (indiscernible)

Q: ok

B: I need to talk to you and ask you this, I know that you guys were passing dope back and forth, ok, who in Anchorage is getting a cut

Q: of your dope

A: who in Anchorage is getting a cut of the dope

B: yeah, when you guys are bringing dope up, who in anchorage are you guys dealing with as far as the dope goes?

A: Hawk wasn't dealing with nobody, Hawk was

B: running his own

A: Hawk was (indiscernible) why he was so bad, yeah

B: (indiscernible) to anybody

A: yeah, because he was so, he was so un un what is the word, un, un, unorthodox, he

Q: hmmm, there is a set of rules that you guys play by and he wasn't playing by them

A: he wasn't playing by them at all

B: yeah

A: and that is another thing, and that is another thing that Bill said, Bill said he had (indiscernible) Bill said it was a matter of time before somebody else got up there and he didn't want nobody else to get what he thought he deserved

Q: all right so Hawk was making more people in the drug world upset other than Bill, was that the impression you were getting from Bill?

A: (indiscernible) Bill was basically telling me that he wasn't walking a fine line like he had major, major dope

Q: eh.. ok

A: he was acting like he was selling two or three stones, is basically what Bill said and Bill basically put it to me like eventually somebody is going to get him, I just don't want nobody (indiscernible), that's basically what Bill said to me

Q: right, ok

A: Bill was just greedy, that's the bottom line sir

Q: so Bill never promised you any money, if you do this, I will give you know twenty thousand, thirty thousand because the big thing is Bill is in custody and that's why I want to get your side of the story because Bill is in a lot of trouble in California and I am sure that Bill is going to try and make you look like the bad guy here and both Dahlke and myself know that is not the case, ok so we just want to make sure that we cut all of that stuff off right

now because when Bill and Bill is going to go into survival mode here pretty quick and he is going to say hey, I'll make you a deal, he is going to say it was Jay, this was all Jay's idea

A: it wasn't my idea sir you know it wasn't my idea sir

Q: I know that, but I just want, so he wasn't going to give you any money

A: No sir

B: he is looking at big time

A: he basically told me sir that whatever he got that I would get a cut of it, but he didn't tell me nothing

Q: he didn't tell you how much it was or anything like that

A: (indiscernible) whatever he would give me dope or money, he said he would go out on a limb, that's how know that I think about it sir, that's how, that's' how off, off this guy was he was really going out on a limb to get just whatever he could, he didn't have nothing guaranteed. It was just his trip, I'm going to see what I can get.

Q: be it a couple of rocks, a million bucks

A: yeah

Q: or ten keys, he didn't care, he was just

A: his trip, this is where it had to happen, that is basically what he told me, from the last time in November when I had lied to him and told him no he didn't get nothing and then ah, and then somehow he (indiscernible) his way back into Hawk and got in to it with Hawk and Hawk (indiscernible) and that is when he came back to me and like you lied, you lied and that (iniscernible) "F" that, the next trip it is going down regardless

Q: right, ok I know Hakeem was a good friend, Hawk, and stuff but how much dope was Hawk pushing up here, say on

A: I will put it to you like this sir, Hawk was making it,

Q: say like

A: when nobody knew he was making it

Q: k, how many keys a month do you think he was getting up here

A: that's about it

Q: a key a month, ok

A: he could have got more but Alaska is so far away, it takes you three days to get down there, it takes you two days and it takes you a week up here to sell it (indiscernible)

Q: Right, now was Teacka muling for him, so like if he would fly down and make the deal and Teacka would bring it up, stuff like that, ok, would he ever have you bring it up

A: I was going to bring up my own stuff, Hawk, that's why I feel so bad because Hawk, (indiscernible) Hawk, I turned my back on him

Q: k, were not, were not drug investigators so you will have to excuse or ignorance we don't know about this stuff, how would somebody in this day and age, after 9/11 how do they even bring a key of coke, how would Teacka bring the key of coke up here, would she

A: that's the whole point, sir

Q: would she put it on her person

3842

A: that's what happens, you put it on your person, that's the whole point sir, it is impossible to bring the whole key

B: you got to break it down, (indiscernible) bring it (indiscernible) trip

A: yeah, Hawk had a lot of people working for him

Q: sounds like it

A: I'm going to give you two more names, I want you to go talk to these two people

Q: k

A: and they will tell you about the whole situation, they will tell you about, Hawk (indiscernible) they will tell you what kind of person Bill was, one of the guys lived with and and he knows Bills character, he he got away from Bill, really Hawk was the one who got him away from Bill because Hawk was gonna (indiscernible) man, you're a grown man, man because this is (indiscernible) get away, get away

Q: right

A: Shelly and Shelmar Johnson are two brothers

Q: Shelly and

A: Shelmar

Q: Shelmar Johnson

A: yup, they are two brothers

Q: ok

A: right now they are in Baltimore

Q: that makes sense because one of the bags that he had in his possession that was in your car that went on this trip it had a tag from horizon, it had a tag from horizon, with a Fairbanks luggage tag and the name on it was Johnson, ok so that makes sense

A: that was Shelmar's

Q: (indiscernible)

A: it was probably, one, it was either one of them but

Q: and they are in Boston

A: no, Baltimore

Q: Baltimore, you know how to get a hold of them in Baltimore

A: one (indiscernible) get a hold of, need to talk to Killer or Sleeze, either one of them can get a hold of

Q: what are those guy's names

A: who

B: what are their nick names

Q: their nick names

A: oh, they don't have any nick names

Q: they just go by

B: Shelmar

Q: Shelly and Shelmar

A: Shelly and Shelmar, or Shelly, really both of them have the same nick name

Q: right Shell

A: Shell, yeah

Q: ok

A: they just that, (indiscernible) wasn't cool talking about

Q: ok, all right and they lived with Bill

A: no, Shell did, Shelmar

Q: Shelmar lived with Bill

A: Shelmar lived with Bill, Bill, everybody knows that Bill was crazy, you should talk to the Coffees, Bill shot up their house, I wasn't even here for that but I just heard about it (indiscernible) and, and you guys are investigators (indiscernible) you know about that

Q: well I, I remember, remember the incident

A: (indiscernible) died, (indiscernible) shot at their house

B: yeah

A: (indiscernible) shot at (indiscernible) Coffee's that day it just so happened (indiscernible)

Q: I will have to look back because I know that that the City police investigated that but I don't know if they ever figured out who did that

A: he said, he said that he was in somebody else car, they drove by and shot up the building and he went and got his own car and drove back by and he said he watched you all out there picking up his shells, (indiscernible) I don't know, he was off, anytime you go back to the scene and you going to watch the police pick up your shells

Q: yeah, that's pretty, sounds like he was a risk taker, took lot of risks, he uh, anything else you can think that would help us out help you know us understand a little bit more about what happened here, I have the utmost respect for you

A: I have respect for you guys to

Q: about wanting to talk with us, about coming clean, I guarantee you are going to feel better after today because you got it off your chest, and that means a lot

A: I think that I will

Q: you know the truth is out

A: you guys, you guys are just, I have come, I've run across a lot of cops in my day and I never even (indiscernible) just because he says the law is (indiscernible) mean it not even, I mean, I mean don't get me wrong, but I'm just, this is society I am a young black male

Q: sure

A: I am pretty sure you guys know how it is

Q: I don't blame you for thinking they way you think, there are bad cops out there just along with the good ones

A: yeah but, but the way society is, is that is the stereotype that I have on me, I am a young black male so it's all just on me, I mean I'm not always wrong but it's just going to be a little bit hard to make people believe in me

Q: sure

A: but

Q: did you have any questions for me

A: yeah, I want to know, I want to know about my wife

Q: your wife is fine, she uh she is without a vehicle because

A: it was impounded

Q: it was impounded and we did the search warrant on it but I think they, they were going to give that back to her today, the uh, she's fine, she, I tried to talk to her last night before I flew back out and she was not at home I am assuming she must be over at uh

A: Sheana's house

Q: Sheana's or possibly maybe your parents house

A: (indiscernible) right

Q: no, I don't

A: (indiscernible) Lacey Washington

Q: one of the people brought up Lacey so I am sure that they know where your mom and dad are then

A: they are (Indiscernible) Lacey Washington and my dad called, my dad, he, he (indiscernible)

Q: your wife said that, Mrs. Bushnell said the same thing, they said he could not have done anything like this, that he is a God fairing man (indiscernible) and I understand now that we see the big picture exactly what you told us happened is what we thought happened. You, you know that there are consequences for your actions

A: yes sir

Q: but the big thing is that your wife is still alive probably because of you so I understand what , I understand

A: (indiscernible) uh, uh you guys are going to be there when the court time is right

Q: k, we are going to write up our report, were going to put in exactly what you said,

B: that you were honest and straight forward with us

A: (indiscernible) out, right

Q: yep, we are going to put in that you were honest, that you didn't BS us, that you understand that what you did was wrong but this is why you did it,

B: your fear for your wife

Q: fear for your wife, all that is going to be in there, and that is going to help you out, this is not some premeditated thing that you went and did, I mean you didn't kill Corey, you could have, you didn't kill Jackie, you could have, but you didn't

A: I couldn't do it

Q: exactly you couldn't, um and like I said it's because Bill is sitting in Washington and he has already killed two people, and know he is sitting there next to your wife, k so like I said we understand,

A: I thought, I thought he was lying, I didn't think he was going to do it

Q: so

B: before we leave here, I need to get pictures of your hands, (indiscernible) um (indiscernible)

A: I wanna tell you more, there's more

Q: k, I am here

A: I want to get it all off my chest, all off my chest

Q: I respect that

A: I want to put it all out there in the open

Q: I respect that

A: so when, because, because I know that time will come where it is going to be my word against Bill's word, I'm going to put it all out there

Q: k

A: and I know that God is on my side, because he told me that, God knows what really goes on, (indiscernible)

Q: you can't hide anything from God

A: (indiscernible) that's right (indiscernible)

B: (indiscernible)

A: you have to talk to Shelmar and Shelly, they know Bill

Q: ok

A: they know Bill, they know how Bill is, ask anybody about Bill, (indiscernible) you are a detective right

Q: that's right

A: and you have been a detective around here for a long time right

Q: I have been with the Trooper's for going on ten years

A: (indiscernible) you know Bill ain't never (indiscernible)

Q: we know William Holmes

A: (indiscernible) authorities around here (indiscernible)... everybody (indiscernible)

Q: and, rightfully so, rightfully so, I understand why they would

A: (indiscernible) would I go, would I go anywhere with him, like people (indiscernible)

Q: sure

A: (indiscernible) it's like they know that, I didn't know, because I had been gone for so long that, that I guess that whole little (indiscernible) that that I was gone that's what he was building up his little rep...so whatever it was, but (indiscernible) and when I came back I thought he was the same Bill, that I knew from seven years ago

Q: but he wasn't

A: he wasn't, (indiscernible) same Bill we knew seven years ago (indiscernible) but it never came out

Q: do you know of anyone else that Bill has killed, no one has never said, hey I think Bill offed this guy or something like that

A: not that I know of sir, so what, what do you know about Bill you said you have heard Bill's name a bunch of times

Q: well just his criminal past, his criminal history, um, you know that we have dealt with him, um I know our drug guys have talked to him a little bit or have brought up his name when we mentioned his name they were like, yeah, he is kinda of on a, he's, he's, he's on our radar, they know of him, they know he is a player and things like that, he's not, when ever his names is brought up it's not who? It's like ok

A: and they knew Hawk was on, Hawk was a player to (indiscernible)

Q: I understand, I, I can honestly understand why you did what you did

A: (indiscernible) see my (indiscernible) Scott

Q: I hear ya

A: I (indiscernible) that's it and that's all I wanted was just to see my (indiscernible)

Q: I hear ya

A: I was (indiscernible) and some how (indiscernible) you know (indiscernible) up

Q: well you know when you move away, I moved away from my small town and go back to visit friends and times change and people change

A: I thought it was the same Bill but and that's why I didn't tell Hawk really cause I was like

Q: you just thought he was talking smack

A: yeah, ah na Bill, na ah, not Bill

Q: well like I said you seem like a nice guy so, and I understand, and like I said everything that we told you here today were going to do for you, k

A: (indiscernible) guys

B: hey we mean that dude, but

A: (indiscernible) guys

B: were not lying to ya

A: I (indiscernible) according to my Pa, I know justice has to be served but

Q: have you ever heard that the truth will set you free, cause you told the truth here today, it is really going to help you out, I understand why you did what you did

A: (indiscernible)

Q: exactly

A: (indiscernible) for me to lie sir

B: yeah well (indiscernible) and that's between you and the DA's office we don't have anything as far as control over that but well tell them ya know, Jason just like I told you when you walked in here, ya know we are going to be honest and open with you and right now

A: I told you I was going to be honest with you, do everything I (indiscernible) you guys

Q: and I, I appreciate it

A: I, I, I want to tell you guys what, what made me tell you everything, once you told me that Bill was in jail then that just let me know that my wife was all right and I could start talking to you all

Q: your wife is safe and the information that you are giving us is going to keep him there, and he is not getting out and he is not going to be able to hurt your wife

B: (indiscernible)

A: (indiscernible) because, because uh, because yesterday when you all came by to talk with me, I knew he wasn't in jail so I knew I couldn't say nothing because I was scared that if, it's because if would of even got a little hint that I had got locked up then he would have, he would have went on a rampage

Q: no, like I said he is, right now he is in jail in Tacoma and he is waiting extradition down to California and he is not getting out of jail.

A: so, will Bill have to come back up here to

Q: nope

B: nope, he will never be back (coughing) (indiscernible) California

A: so, I might have to uh, I might have to fly down there and go to court then

Q: I don't think so

A: (indiscernible)

Q: well, maybe

B: maybe

Q: yep, maybe, um if that (indiscernible)

B: what he is saying (indiscernible)

Q: yeah, that, that's a question for the District Attorneys Office down there and ours up here and things like so

B: luckily it was only on your one hand huh, your right hand that got burned bad, you got a pretty good burn

Q: have you seen the nurse about those

A: no, not yet

Q: make sure they don't get infected

B: yeah

Q: burns can get infected pretty easy

A: I can't believe it, I still don't, I just, (indiscernible) never see my wife again

Q: the uh

A: can you guys tell me

Q: well like I said a lot (indiscernible)

B: as far as seeing her is concerned

A: I am talking as far as like, cause I know how the court system works,

B: (indiscernible)

A: I know you guys are going to help me out but there not going to prevent me from going to jail

Q: the uh, the big thing

A: I don't care if I have to do ten years or whatever, I just want to be able to get out and see her

Q: I understand, and like I said that, that's up to the DA's Office, but, see if, we will do what we can for you. Like I said we are going to tell the DA that you were honest and straight up with us and uh, and everything that you told us about why you did what you did is going to be in the report, were not going to say that you are some maniac out there doing things all on your own, cause that 's not the truth, k

A: cause the DA made me look like I was a dark person and everything,

Q: well in the complaint

A: yeah, (indiscernible) I was a criminal history, I (indiscernible) flee the state, I was like man that's that's not me.

Q: right

B: yeah

Q: I understand

B: Jay would you look right at me for a just second I got, I want to take your picture

Q: and Jay something that we will do for you to is uh...

A: am I still on full phone restrictions to sir

Q: well

B: we, we, we did not know that, so (indiscernible)

Q: we will work on that

B: we will see if we can get you taken off of that, ok I didn't know that you were on phone restrictions so

A: I thought that you guys had it put on there (indiscernible)

Q: I have been in Washington

B: wasn't me

Q: but like I said if that is the case

B: maybe one of the other cops might of or one of the other Troopers might have

Q: but we will check into that so

A: do you have any other questions for me

B: no sir and I know that you are probably tired and want to

A: (indiscernible)

B: we'll get you out of here ok

A: there's more out there, there 's something I wanna, something else

B: something else that you want to tell us

A: I haven't told enough yet (indiscernible) there is more to it, there is more to the story.

Q: Corey and Michael Keys they weren't wrapped up in, in doing any harm to Teacka

B: nobody helped kill Teacka, at all, it was just you

Q: k

A: they were all, Bill wanted all of them dead, (indiscernible) Bill wanted, these are all the people who Bill said had to die, and that's what he told me, he said that they got to die, he said Big C got to die, he said Hawk got to die, he said uh, he said, uh Corey got to die, Jackie has to die and Jackie was disturbing because Jackie has a kid, so that's another reason

Q: right

A: I was like man, she doesn't even know what's going on I

Q: when I was in the apartment, there was a lot of kids things over there weren't there

A: that that (indiscernible) on my heart right there

Q: uh huh

A: he said that Mike had to die and then he said that uh, the people down in Washington, he said that anybody seen him they had to die to

Q: right

B: and you know who that means

A: I think that Keanna seen him, I think that what you call it, Johnny (indiscernible) does the name Johnny ring a bell, Johnny Wallace down in Washington, that's where Hawk would uh

Q: work

A: uh

Q: does he own a landscaping business or something like that , no

A: Johnny Wallace, he (indiscernible) that was the halfway point. Johnny Wallace was like the hub in between California and Alaska

Q: and Alaska, Johnny Wallace

A: that's where all the work would stop at and that's where it would get broke up at and then that's where everybody would fly out to, that's where Shelly would fly to, that's where Shelmar would fly to

Q: does he live in Tacoma

A: uh huh, I wouldn't fly there because I live there (indiscernible)

B: do you now his address down there

A: uh, I would tell you, I know that he stays uh, he stays on 96<sup>th</sup> and Hadler uh (unknown spelling)

Q: Hadler?

A: Hadler

Q: 96<sup>th</sup> and Hadler

A: Do you know where Keanna stays at

Q: no, they detectives down there though dropped Keanna off at Keanna's apartment so they know where Keanna stays

A: Keanna knows, Keanna knows where Johnny stays at

Q: ok and there is a lot of drug activity going on at John's house then

A: na, na (indiscernible)

B: already taken down

A: Hawk was , but before Hawk got him because he smokes weed and drinks and that is all that Johnny does

Q: ok

A: so now that, now that nobody's around nothing going on there, (indiscernible) drinking and smoking weed that's about it

Q: do you know do you know someone named, is it Amber

A: Amber

Q: Amber

A: no, where is she from

Q: she is a white gal, blond hair

A: down in Washington

Q: yeah

A: I, I, I have herd of the name, she was seeing Hawk wasn't she

Q: I think so

3850

A: yeah, I have never seen her but I, but I have heard Hawk talk about her

Q: ok, ok

A: I have heard Hawk talk about her

Q: because that name up down there, do you know where they were heading to in California, where was that, where were they heading to

A: they were going to uh, I think they were going to the bay area, somewhere in the bay area but I don't know exactly where at in the bay area

Q: do you a name that they were going to contact down there

A: Big C he was, he was the connect

Q: ok

A: Big C was from the bay area that's all I knew

Q: ok, they run down to Oakland maybe or

A: I have no idea, it would be Oakland, Sacramento, San Francisco, (indiscernible) one of those areas right there in the bay area, they call it the gay area so it could have been anyone of those places in there (indiscernible) buy dope, that's like the nick name for the bay area \

A: and I know Big C (indiscernible) connect

Q: and that was, tell me this, if you had, how much does a key cost, because they were going down to buy a kilo, how much cash would they have to take down there, because I don't know

A: I would say anywhere between 50 to 70

B: per key

Q: per kilo

A: that's, that's just what I've heard, I don't know exactly what they were paying for it, because, because they don't tell me everything

Q: have you ever seen the drug money that they, that they use to buy this stuff with, I mean have ever seen any of it, ever

A: Hawk was, call it weird cause, Hawk was, I don't know he was just, he was, Hawk was weird, he was he would show some stuff but then wouldn't show other stuff

Q: uh huh

A: and then he would talk about this but he wouldn't talk about that, he was just, I think he was just unorthodoxed

Q: do you have any idea where Hawk got his money from or where the money for this trip

A: selling drugs

Q: but where did the money for this trip came from

A: selling drugs, it came off the key that we had first

Q: In November

B: the key that you guys brought up

A: the key that all of us took up, all of us took it up, it was me, Shelly, Shelmar, uh, Killer, Corey

Q: Corey Spears or Corey Keys

B: Killer is Keys

Q: no that is Michael Keys but there is a Corey Keys to, when you say Corey are saying

A: Corey Keys, I don't know that there is a Corey Keys, who's Corey Keys, I thought it was uh

Q: Mikes brothers, Killers brother

A: I thought it was Corey Spears

Q: There is a Corey Spears to

B: (indiscernible) Corey Spears

A: see I don't know nothing about uh

B: Sleeze

A: Yeah, Sleeze is uh (indiscernible) Corey Spears

B: Corey Spears

Q: so all these

A: I don't know nothing about Corey ah

B: yeah, Mike, Michael Spears or ah oh I am sorry Michael Kelly, god, Mike Keys, see there is so many people

A: (indiscernible)

Q: here in Fairbanks

B: yeah and his name is Corey

Q: did, so now, let me get this right the key that you guys brought up in November, how many people brought that thing up

A: like there was me, Shelly, Shelmar, Corey, Killer, that's five, uh "T" ah there was seven.

Q: seven, where do you guys carry it on your person when you come up

A: it all depends, you can put it anywhere, you can put it anywhere

Q: how is it normally packaged when you guys bring it up

A: are you talking about the whole key of coke

Q: no like

B: when you break it down

Q: if you give me part of it to break down and carry up is there a certain way you guys package it

A: yeah

Q: to make it less noticeable

A: you just put it, it's like, it looks like, it's not (indiscernible) it is like this size right hear, it's like three (indiscernible) it's about this long and about that thick, it is about that thick right there and you just put it anywhere on your person that you can hold it

B: is it taped to your belly or

A: any, anywhere, tape it to your belly, tape it to your leg, tape it to your arm pit, because, because you go through the airport they only check metal,

Q: ok

A: and they aren't allowed to uh

Q: touch you

A: frisk you, yeah so as long as I don't got metal on me, they, they can't touch you, the only thing they can do is wand you

A: and the, and the wand can't feel that on you

Q: is

A: and the only way (indiscernible) if they rub the wand and it beeps like, your belt buckle beeps, (indiscernible) right there but they can only rub where it beeps at

Q: is there a reason why they fly into Anchorage and not directly into Fairbanks

A: Hawk said that Fairbanks is way to small

Q: to many eyes on Fairbanks, more people going through Anchorage

B: to hot

A: yeah he said that it was to small, he said, he said that if one person comes through Fairbanks everybody knows it. That's what he said

Q: ok, that makes sense

B: yeah, a lot more traffic
