| INTERVIEW WITH KEVIN BRADLEY: (Continue               |                                   |

BRADLEY advised that Joey SHANK was the designated driver and he took everyone except himself and Clark to the Eagle's Hall in BRADLEY's mother's car. BRADLEY thought that SHANK returned a short time later as if he had gone directly to the Eagle's Hall and back. BRADLEY stated that none of the suspects had telephoned him after they were arrested.

## INTERVIEW WITH CALVIN MOSES:

On 10.13.97, Inv. GEIER conducted an interview with Calvin MOSES and the contact was recorded. MOSES was driving his vehicle, and was accompanied by Louise LAMBERT and Christine JOSEPH, when they found the body of John HARTMAN.

MOSES stated they left the Arctic Bar on their way to the Towne House Hotel when they stopped momentarily at Midtown Apartments. Christine JOSEPH picked up some of her belongings and then they continued to the Towne House Hotel down 9<sup>th</sup> Avenue. When they reached the intersection of 9<sup>th</sup> Avenue and Barnette Street, they located the body of John HARTMAN.

MOSES stated that HARTMAN was lying on 9<sup>th</sup> Avenue with his legs on the curb. MOSES said they did not observe anyone walking or driving as they approached the area and it was very quiet. He stated he could tell that HARTMAN was still breathing because he could see his breath in the air. He said they didn't feel it was safe to get get out, so they drove directly to Towne House Hotel and called 911.

## **INTERVIEW WITH SHARA DAVID:**

On 10.13.97, Shara DAVID was interviewed by Inv. GEIER and the contact was recorded.

She advised that she arrived at Kevin BRADLEY's house between 2230 and 2300 hours. She said she was with Shawna GOEBEL, Dana ANDON, Joey SHANK and they were driven there by Kevin BRADLEY in his mother's car. She stated while they were at the house, BRADLEY had left to go pick up a friend named Clark and, while he was gone, Kevin PEASE, Eugene VENT, Allen SISTO, Eddy KOOTUK and Nathan CARROLL arrived.

Shara DAVID then described the time they left BRADLEY's house and she thought it was two twenty-something because she had glanced at a clock. When DAVID was questioned further about the time, she stated the clock may have been wrong or it might have actually been 12 twenty-something and didn't' see the number one.
