

### FY15 Budget Information

- Anticipated \$15M Budget Reduction / Deficit
- Personnel Fixed Cost Increases
  - Non-Represented Staff 2% ATB + 1 PHL Day
  - UNAC Faculty – 2% ATB + \$750
  - FT – Avg 2% (1% 0-5, 2% 6-11, 3% 12+)
  - UAFT Faculty – 2.5% ATB
  - Local 6070 – No agreement in place



### FY15 Continuation Budget



- Adjusting the Process: No More “Sheet Numbers”
- Each operating unit receives one sheet, balanced by D-level and NCHEMS.
- This may require org structure adjustments if budgetary units are currently not rolling at the unit level (level 4)!*
