



Shuttle Bus Advertising Guidelines

Purpose

Advertising on University of Alaska Fairbanks shuttle buses is designated for on-campus university programs (including entities with university contracts, student organizations & functions) and community businesses on a first come first served basis.

Size

Ad frames on the buses are set up to handle 11 inch tall signs. A standard size ad is 11 x 17. All ads must be printed on paper with a standard dimension of 11 x 17 inches and then laminated to a finished size of 11 3/8 x 17 3/8 inches.

Content Guidelines

All ads are subject to approval by the Business Manager of FS-Auxiliary and Contract Services or appropriate staff before display. No Political Advertising will be accepted. Ads posted from a bar or drinking establishment must follow these guidelines:

All ads must be focused on the program (i.e. band, performance, etc.) being advertised and NOT on drink specials or drinking related activities.

All ads must contain a moderation message in regards to responsible drinking.

Scheduling

All ads will be posted on a Monday-to-Sunday basis only. All ad scheduling will be on a first come first served basis.

Fees

A bus advertising fee will be charged per week to any community, or business organization wanting to advertise.

There will be no charge to university organizations who want to advertise on the buses. There are a limited number of spaces per week. University Organizations are responsible to cover all printing costs for their ads.

Payment

Payments may be made in cash, check or credit card (Visa/MasterCard)

Terms:

30 days from invoice date. Prepayment required from individuals or first-time advertisers.
