## **LASTING LEGACY**

Brina Kessel, a renowned ornithologist and UAF professor, dean and museum curator emeritus, left n incredible \$7.5 million to the University of Alaska Fairbanks when she passed away March 1, 2016.

Brina's name is all but synonymous with ornithology in Alaska. Starting her career in 1951, Brina advanced from instructor to full professor to dean of what is now called the College of Natural Sciences and Mathematics (CNSM). In 1980, she transitioned to the University of Alaska Museum of the North, where she focused her efforts on research and development.

Brina was a trailblazer for women scientists in a time when fi ld work and even academic work was often barred. Her work led her to accompany the famous conservationists Olaus and Margaret Murie on some of their trips to far northern Interior

Alaska. She was the fi st woman to serve as a dean of CNSM.

Kevin Winker, the museum's curator of birds, said Kessel made pioneering contributions to our knowledge of

Alaska birds. "And with this generous gift, er contributions to ornithology will fly on in perpetuity through the students and research it supports," Kevin said. Brina had supported many organizations affiliated with her love of the tundra and ornithology.

Brina's love of Alaska and its avian treasures led to a lifetime of exploration. Her modest style of living and dedication to her work complemented her quiet prowess for investing. Brina's multimillion-dollar estate gift ill benefit the Brina Kessel Fund for Northern Ornithology, which




