Revision of MPC Bylaws

Rich gave an overview of the reasons for the proposed changes to the bylaws.

Bill pointed out that we need to define "working group".

Deb pointed out that working groups are appointed on an "as needed" basis.

Doug stated that the intent of the "working group" is to allow flexibility.

Deb suggested that the working group would have a finite scope of work.

<u>Facilities Services Update - Jonathan Shambare</u>

LED lights have been installed by Lola Tilly east entrance and will be installed by intersection of Tanana Loop and Yukon Drive.

DOT had indicated that LED street lights are not acceptable for general use. Most likely Facilities will not propose LED lights for streetlights.

Sewer problems by Chapman have been corrected.

Consultant has been selected for work (grant funded) on addition to Harper Building.

Deb asked if the proposed changes had been brought to MPC. Jonathan agreed that it had not.

The gatekeeper should be Office of Sponsored Programs (OSP) when grant funding is involved. The OSP proposal routing form requires Investigator to specify facilities changes or new capital projects.

Rich will speak with VCR regarding ensuring communication with MPC when review is required of proposed capital projects in research and other proposals.

November 16 and 17 is the open forum for the Perkins & Will presentation.

Scheduled meetings with Perkins & Will are on MPC calendar.

Planning for the "Constitution Wall" in Signers' Hall is moving forward. Deb met with Ann Ringstad and Tim Stickel to discuss the process and people who should be involved.

Bonita and Deb have developed a student commuter survey.

Bonita described the survey. It will be for both undergraduate s and graduate students who commute to campus.

Gary suggested contact with Karl Kowalski (OIT) regarding administering the survey.

Subcommittee met last week. Members want to talk with Perkins & Will about how we connect open space (green infrastructure) on campus. They also are interested in giving more attention to winterscapes.

Plans to establish the birch grove, one of the West Ridge learning habitats, are underway.
