STATEMENT OF APPROVAL AND USE

Permission to reproduce images of cataloged items and works of art from the University of Alaska Museum of the North (UAMN) is granted upon acceptance of the conditions described below. Any breach of the following terms and conditions will result in revocation of permissions at the discretion of the UAMN.

Upon completion and return of this form, UAMN agrees to provide materials requested on this form to the undersigned requestor for use in a print or digital publication, motion picture production, public presentation, exhibit or display, or other printed, digital, or filmed medium, hereafter referred to as the Product. The applicant understands and agrees to all conditions below:

- 1. Materials are provided for world-wide use in-perpetuity for the life of a single-named Product, in all forms of media, including promotional media directly related to publicizing the Product.
- 2. UAMN holds copyright for some, but not all, materials within its collections. For many holdings, copyright ownership or other rights issues are unclear. It is the sole responsibility of the applicant to determine any rights that may exist and to obtain all necessary clearances to use materials for any purpose. This form does not constitute a license for use of materials where copyright is not held by UAMN or the University of Alaska. Appropriate use of Indigenous materials may exceed the scope of US Copyright law. UAMN recommends that applicants consult with relevant cultural heritage organizations or authorities to ensure proper and respectful use of potentially culturally sensitive materials.
- 3. The applicant assumes all liability for use of UAMN materials and agrees to indemnify and hold harmless the University of Alaska from all claims, actions, judgements, and expenses arising from applicant use of material obtained from UAMN.
- 4. The applicant agrees to cite material accurately. See above for proper catalog number reference and page three for any additional credit information. For web publications of still images, the citation must be part of the image itself. For motion pictures, the required screen credit that may appear at any point is: University of Alaska Museum of the North.
- 5. The applicant agrees that materials will not be used as stock images or footage. The applicant agrees that materials are not provided on an exclusive or transferable basis.
- 6. The applicant understands that fees may be charged for providing materials managed by UAMN. Any fees do not constitute a licensing, use, or copyright fee.
- 7. As a courtesy, UAMN requests that the applicant provides a URL link or copy of the Product, without charge, in which materials appear.
- 8. For reproductions of original works of art, the reproduction must be printed in full tone black and white or full color and may not be reproduced on colored stock. Nothing may be superimposed over the image without approval from UAMN. The image must be reproduced in its entirety and must not be bled off the page or cropped in any way without permission from UAMN. The reproduction of a specific detail must be approved in advance by UAMN and the fact that it is a detail noted in the documentation accompanying the reproduction.
