**Critical Energy Industry Employee Authorization to Travel**

To Whom It May Concern:

The individual in possession of this letter, accompanied with a valid ID (driver's license, passport, REAL ID, etc.) and a ConocoPhillips-issued identification card, is an employee of ConocoPhillips Alaska, Inc. in support of oil production operations in the Alaska petroleum production industry, which may include air and ground travel to and from Alaska and air and ground travel within Alaska. The petroleum production industry has been deemed by the U.S. Government and the State of Alaska as critical infrastructure, and workers in the industry are exempted from travel restrictions related to the COVID-19 pandemic.

On March 16, 2020, President Trump issued the President's Coronavirus Guidelines for America. Those guidelines provide that, "If you work in a critical infrastructure industry, as defined by the Department of Homeland Security... you have a special responsibility to maintain your normal work schedule." Pursuant to the United States Department of Homeland Security - Cybersecurity and Infrastructure Security Agency's Memorandum on Identification of Critical Infrastructure Workers During the COVID-19 Response, dated March 19, 2020, petroleum workers have been identified as essential critical infrastructure workers. In addition, the Energy industry has been designated a "Critical Infrastructure Segment" under Presidential Policy Directive 21 and Department of Homeland Security emergency readiness programs implementing the USA PATRIOT Act of 2001. 42 U.S.C. § 5195c(e). Similarly, on March 20, 2020, the State of Alaska Department of Commerce, Community, and Economic Development issued a Health Alert on travel, which identified oil and gas production workers as part of the critical infrastructure workforce, and not subject to the travel restrictions advised in the Health Alert. It is therefore the policy of the United States government and the State of Alaska that oil and gas production continue to function with minimal disruption in the event of an emergency.

As such, the individual in possession of this letter is a "critical infrastructure industry employee" of the oil production industry and should be considered exempt from state and local restrictions such as travel restrictions, curfews, shelter-in-place orders, and other mobility restrictions when reporting to, returning from, or performing his or her work functions.

We ask that you allow this individual to travel to the extent necessary to continue with his or her job in the interest of maintaining the services and functions Americans depend on daily and that need to be able to operate resiliently during the COVID-19 pandemic response.
