Course type: Classroom discussion

### Course description:

The goal of the course is to produce a collaborative scientific paper that will be submitted at the end of the semester to a peer-reviewed journal. The class will meet twice a week to discuss progress, assign (and reassign) tasks, do background research as necessary, and work on writing the paper. This class should accomplish several things including teaching students how to work collaboratively on a project and helping students with the process of turning research results into a published paper.

### **Student Learning Outcomes:**

The student will become familiar with working collaboratively in a team towards creating a research paper that is publishable in a peer-reviewed journal

#### Instructional methods:

Regular meetings to discuss research progress, read and discuss background literature, and assign tasks for writing and analysis. The classroom model will follow more closely a 'flipped classroom' model, where the students work on assigned tasks outside of class, and the class meetings are used to brush up and reorient as needed. This could include short lectures, paper discussion, a regular check-in to keep track of progress, a discussion of reassigning goals if progress is not met, etc. I also expect guest lectures from experienced journal editors on the publication and review process, as time permits.

As per UAF guidance, for a 2cr class there is a general expectation of spending 4 hours/week (+2 hours of class time) on class work.

Class attendance is mandatory

## Grading:

Pass/Fail based on participation and contribution. Contribution to the paper will be determined by whether there are clearly identifiable parts of the final paper that originate from a participants work (much how co-authorship works in general). Such evaluation will happen in one-on-one discussions between students and the instructor.
