We have added the words "the Indigenous Perspective" to the title to further differentiate between the two courses additional to the numerical difference that already exists in the catalog listing.



The Alaska Native Studies program is undergoing revision to try to better meet the needs of students while also managing budget cuts. ANS 111 is a course that we have not offered since Alaska Native Studies came to DANSRD in 2010. It has only occasionally been offered by the History Department and usually without the ANS cross-list. We would like to start offering this course and plan to include it in new concentration areas for the ANS program.

As a Native studies program we need to offer this course from an Indigenous perspective which, while of course dates and events remain the same, may include focus on items of importance for Native studies students that would not receive much coverage in other history courses.

With the changes in GERs that are pending we would like to be able to add this course to one of the "buckets" without negatively affecting the History Department who doubtless have courses they would prefer to have in a bucket over this one.
