## 2019 Tuition Award Application New University Students

Summer Sessions & Lifelong Learning (SSLL) may award three (3) credits of tuition for new university students who have fewer than 12 accumulated credits and who meet the following requirements:

1. Minimum 2.5 cumulative GPA.
2. Admitted to UAF as a non-degree or degree-seeking student.
3. Not participating in the Sweet Summer Deal.
4. Submit two reference letters from professors, advisors, employers or other professionals. References may use the Applicant Reference Form or write their own letter.
5. Submit a one-page, typed statement describing how this summer course is important to your future plans. Describe your financial need and any special circumstances you would like considered in the review of this application.

This tuition award can only be used for a course sponsored by Summer Sessions & Lifelong Learning. Eligible courses can be identified by the section number (not the course number) starting with 'F' and followed by a number, not a letter. Directed and Individual Study courses are not eligible. Contact SSLL if you have any questions about qualifying courses.

The deadline for this application is based on the session in which the course is being offered. Deadlines are as follows: MAYmester – April 29; Full Session or Six-Week Session I - May 13; Six-Week Session II - June 24. You will be notified by email when the review of this application is complete.

Alaska Statute AS 14.40, signed by the Governor of Alaska allows the University to garnish the Alaska Permanent Fund Dividend of a debtor with a past due balance of 180 days.
