


Thank you!

Equipment, Data, and Support Services

"We're grateful for all efforts of Toolik Staff to make sure that equipment is not stored in animal housing areas of winter lab. This was much better this year than previous years with the new winter storage space in the garage."

"It's easy to work in all lab facilities."

Specific requests/concerns:

- Possibility to reserve space in other labs/elsewhere to store very large quantities of samples.
- Persistent issues with DI water machine (mentioned in 2017 as well) but efforts of staff to fix this appreciated.
- Daily "snowed"/ "did not snow" data from EDC.

Transportation

- 66% of respondents traveled to Toolik on a Science Truck or DHE vehicle.
- 80% of respondents used NSF trucks while in camp.
- 33% used UAF trucks.
- 7% used MBL trucks.
- 33% used boats
- 20% used snowmachines

Specifically appreciated:

- New trucks
- New reservation system

Specific requests/concerns:

- Wider boardwalks at high-traffic sites.
- More boats (sometimes limited supply).
- "DHE was extremely slow, 12 hours, stopped frequently to look for butterflies."

"Despite being active from dawn to dusk I still managed to gain weight during my three-week stay at Toolik."


Specific requests/concerns:

- Several people mentioned supporting the creation of a scholarship fund for student userdays/travel.
