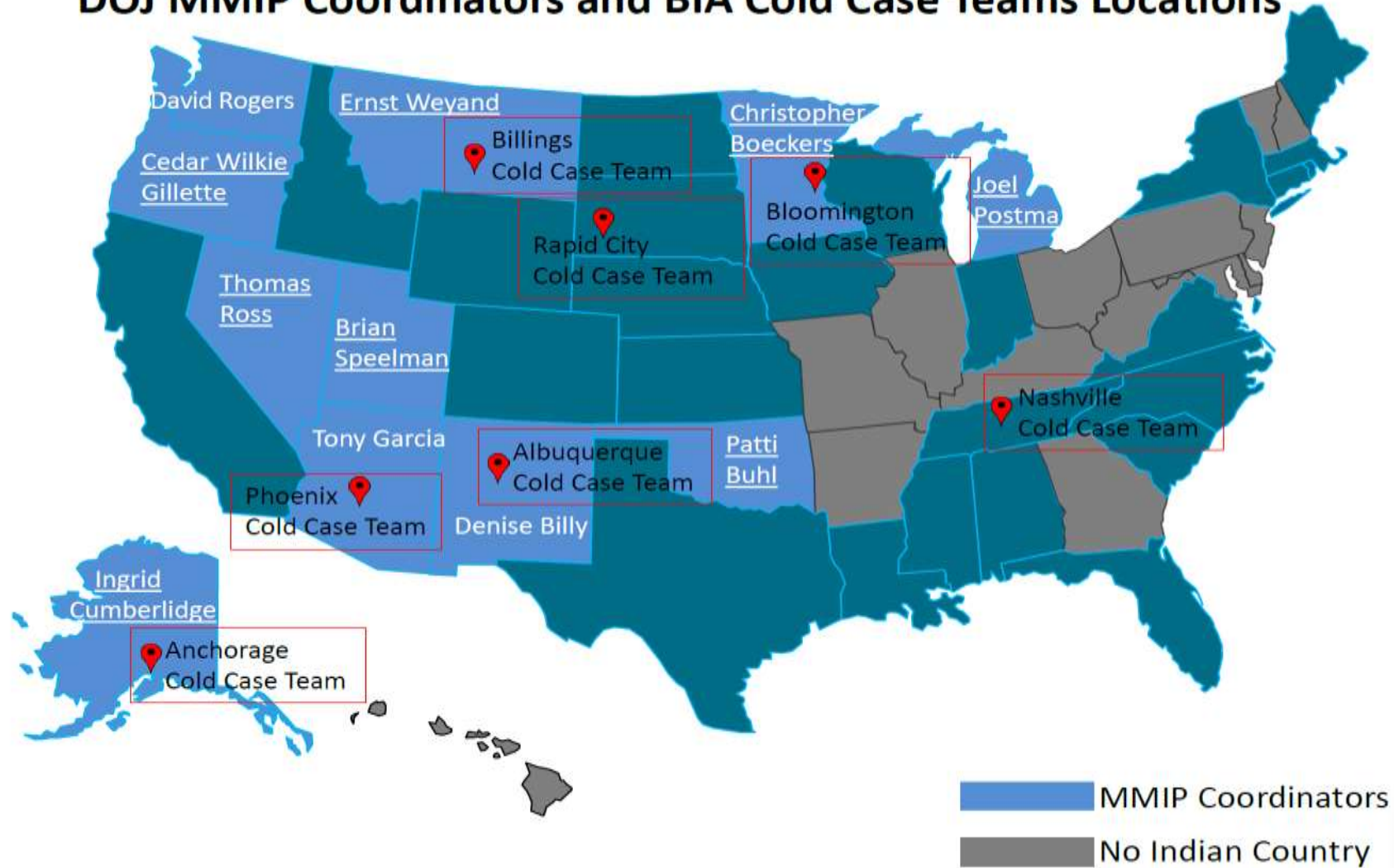

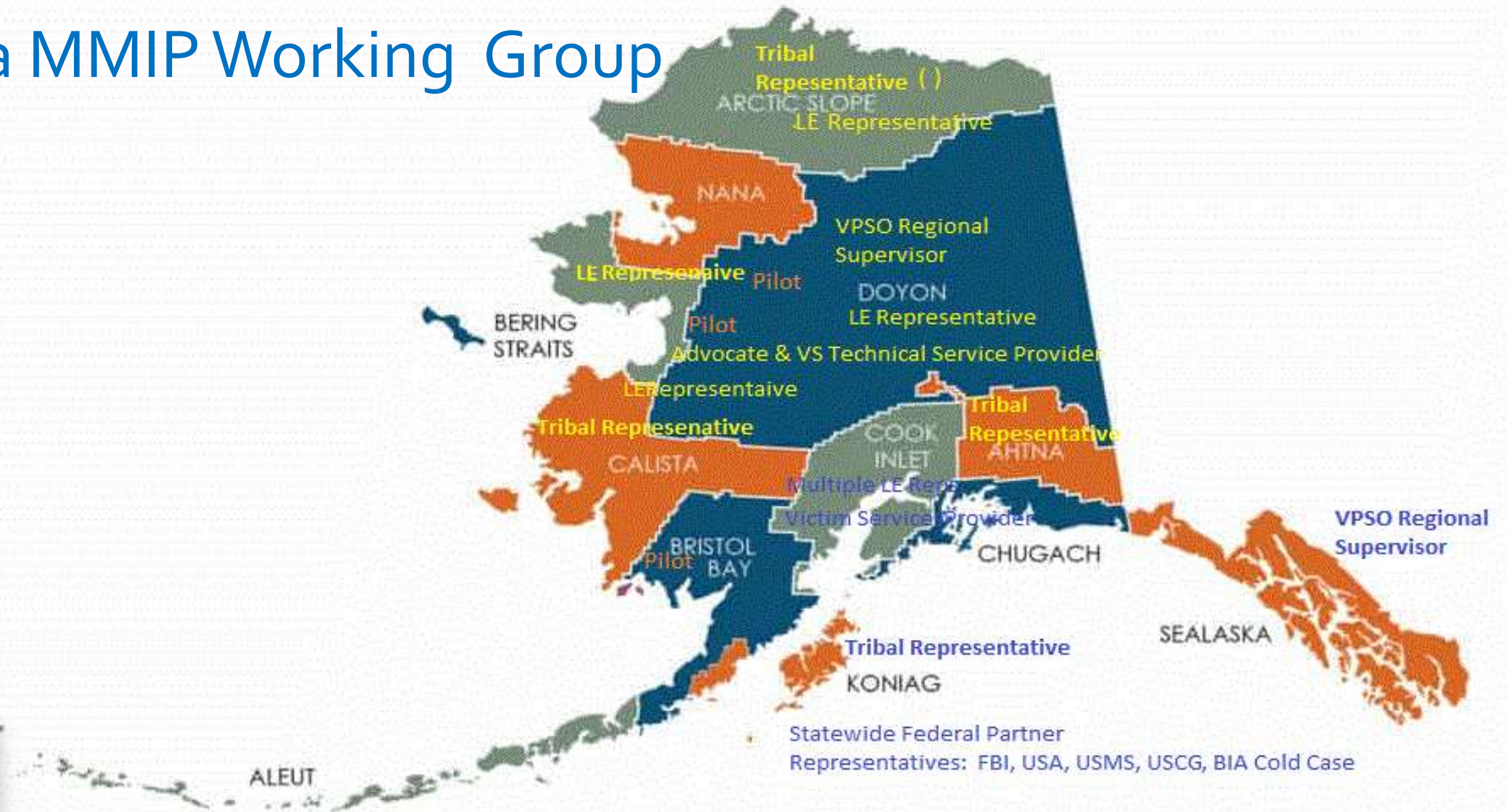


Alaska MMIP -Statewide Working Group

- ▶ Federal, State, Municipal, and Tribal Law Enforcement and Search and Rescue, AK Department of Law
- ▶ 2 Victims Services & Advocate Representatives

Alaska MMIP - Statewide Working Group

- ▶ Building Multi-disciplinary response relationships
- ▶ Identifying MMIP concerns & history
- ▶ Working to develop three Community Action Models
 - ▶ Tribal Community Response Plans (for Pilot Projects & Tribes)
- ▶ Sharing resources & opportunities to collaborate
- ▶ Identified prevention, response, and training needs



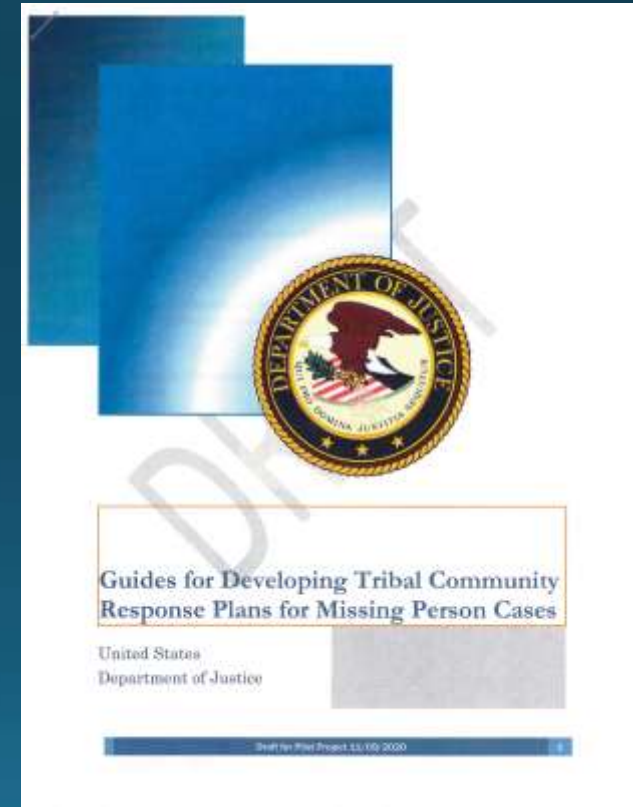
Goal of the Alaska – MMIP Pilot Projects

- ▶ To establish a plan for tribal communities to collectively use their resources effectively in supporting emergent MMIP case, ongoing case, and cold case response
- ▶ To support a multidisciplinary approach to raise MMIP awareness, prevention efforts, training, & response capacity
- ▶ To Identify and respond to root causes (i.e. historical trauma, substance use, domestic violence, danger of media & travel...): support prevention, treatment, repair of harm



AK – MMIP Pilot Project is Comprised of Four Guides

- ▶ Law Enforcement
- ▶ Victim Services
- ▶ Public and Media Communications
- ▶ Community Outreach



Alaska MMIP - Pilot Program, 3 Volunteer Tribes

- ▶ Develop 3 Community Action Models
(Tribal Community Response Plans)
 - ▶ Communities with no law enforcement (LE)
 - ▶ Communities with limited LE (VPSO, TPO...)
 - ▶ Hub Communities with municipal and/or state law enforcement
- ▶ Curyung Tribal Council of Dillingham, Native Village of Unalakleet, & Koyukuk Native Village



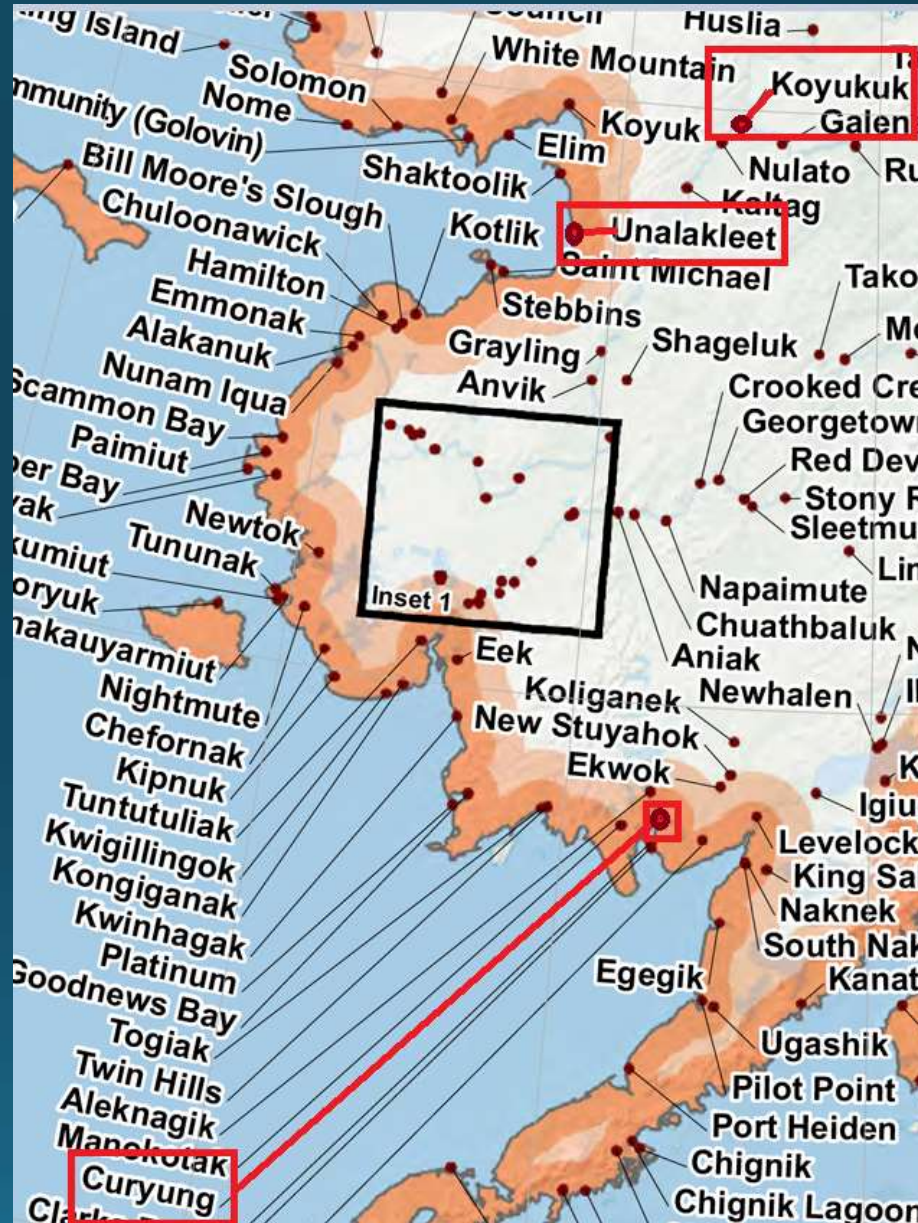

Next Steps – AK MMIP

- ▶ Finish work of AK – MMIP Pilot Projects and TCRP Models
- ▶ Regional AK-MMIP listening/consultation sessions: pilot reports, tribal input, scheduling
- ▶ Continue work with 226 remaining Alaska Tribes by supporting their Community Action Plans / Tribal Community Response Plans
