## FIRE SCIENCE A.A.S. DEGREE in "EMERGENCY SERVICES: WILDLAND FIRE CONTROL"

## **Background**

- 1. 1999: In the 1999-2000 UAF Catalog, "Fire Science" was a separate program, offering three A.A.S. degrees: Wildlands Fire Control, Municipal Fire Control, and Hazardous Materials Control.
- 2. 2000: The following year, as part of some major restructuring of UAF programs, the "Fire Science" program was suspended and in the 2000-2001 UAF Catalog, all fire science programs were combined as concentrations under a new "Emergency Services" A.A.S. degree. The four concentrations were: Wildlands Fire Control, Municipal Fire Control, Hazardous Materials Control, and Public Safety.
- 3. 2007: When the "Paramedic Academy" was initiated in the former Tanana Valley Campus, its courses were placed within the "Public Safety" concentration of the "Emergency Services" degree. This began to cause issues since many students sought training in fire fighting and paramedic, but were not allowed to earn two concentrations under the same A.A.S. degree.
  - 4. 2012: In the current 2012-2013 UAF Catalog, this is how the fire science and paramedic programs are listed.
- **5. 2012:** In the spring of 2012, under another restructuring of community college programs, with guidance from Provost Henrichs, the fire science and paramedic programs were separated into three separate and distinct A.A.S. degrees:
  - a. <u>Paramedic</u>, formerly an "Academy," became a totally new A.A.,S. "Paramedicine" degree. It will appear as such in the next UAF Catalog.
  - b. <u>Fire Science</u>, <u>Wildland Fire Control</u>. Two of the former late 1990's "Fire Science" degrees have been "unsuspended" and are now formally a part of the fire science program. The program's current emphasis is to revise the **Wildland Fire Control** curriculum, since much has changed since the late 1990's.
  - [c. Fire Science, Municipal Fire Control. At a later date, the program will also revise the Municipal Fire Control curriculum.]
  - [d. <u>Law Enforcement</u> As a separate part of the restructuring the current "Law Enforcement Academy" will be melded into the former "Justice" A.A.S., which was suspended at the same time the "Fire Science" A.A.S. was suspended. The former "Justice" A.A.S. has now also been "unsuspended" but a new name and curriculum have not as yet been developed.]

The goal is to offer four separate and distinct A.A.S. degrees: 1) Fire Science, Wildland Fire Control; 2) Fire Science, Municipal Fire Control; 3) Paramedicine; and 4) Law Enforcement.

**Degree Requirement Change:** A.A.S. in Wildland Fire Control.

The format explains the goal of integrating several new courses into the Wildland Fire Control A.A.S. degree, of which several will be wildland foundation program requirements and ten will be major electives to help students better specify their career goal in wildland fire. There will also be a change to several additional courses that are currently part of the degree program. These new and updated courses will realign the degree with current industry standards.
