As related to these specific program changes—required and elective courses within the music theory discipline are now clarified as to sequential order and specific prerequisites. The SLO process within the sequence of courses is detailed within each course syllabus. Students in the 100-level theory courses are

given diagnostic examination prior to completing their first semester. Remediation may be given to students who score low on the diagnostic. Courses include periodic testing, final examinations and, in the upper division courses, term analysis projects. Courses that are required for music majors in B.A. or B.M. programs require that a major student earn a grade of C or high in order to pass the course.




JUSTIFICATION FOR ACTION REQUESTED

The corrections and clarifications are intended to provide students and advisors with better information on the availability, requirements and objectives of courses within the sequence of music theory courses.
