# A. DESCRIPTION OF THE PROPOSED MINOR. Include reasons justifying its creation; objectives of the minor and relationship of the required courses to those objectives.

There is a strong interest in creative writing at amongst UAF's students. However, creative writing courses can only be used to satisfy (h) or (w) requirements, or as electives. This minor aims to satisfy student demand for creative writing to constitute a formal part of a degree program.

Creative writing is already an important and high-profile discipline in CLA: the English Department offers an

MFA in Creative Writing (with 30 students currently enrolled), as well as a combined MFA/MA degree (creative writing/literature). The faculty expertise and program-strengthening structures necessary for the MFA will form a solid basis for the minor: the English Department already has the faculty needed to run the minor, hosts the Midnight Sun Visiting Writer Series (which brings high-profile writers to UAF to present their work, provide craft talks, and meet one-on-one with students to discuss their writing), and is home to two creative writing journals: the undergraduate journal, *Ice Box* and the graduate journal, *Permafrost*.

The minor in creative writing will build on an already necessary restructuring of the undergraduate creative writing curriculum. The proposed new curriculum replaces the current three introductory genre-specific courses (ENGL 271/272/273 that focus on fiction, poetry and nonfiction respectively) with a multi-genre introductory course, offering genre-specific courses in fiction, nonfiction and poetry at the 300-level, and offering the existing Topics in Creative Writing as a 400-level course. Such a restructuring makes for a more pedagogically sound curriculum, providing students a suite of courses that starts with the teaching of principles and skills applicable across the genres then progresses towards more advanced study at the 300- and 400-level.

#### C. ESTIMATED IMPACT

### WHAT IMPACT, IF ANY, WILL THIS HAVE ON BUDGET, FACILITIES/SPACE, FACULTY, ETC.

We anticipate no negative impact from the creation of a minor in creative writing, nor from the suite of new undergraduate courses associated with it. The minor will entail the offering of current 200-level genre-specific courses at the 300-level (i.e. the current ENGL 271 Introduction to Creative Writing: Fiction, ENGL 272 Introduction to Creative Writing: Poetry and ENGL 273 Introduction to Creative Nonfiction will be replaced by the new course ENGL 271: Introduction to Creative Writing; genre-specific courses will be offered at the 300-level as ENGL 371 Creative Writing: Fiction, ENGL 372 Creative Writing: Poetry, and ENGL 373 Creative Writing: Nonfiction). The minor will also offer the current 300-level course (ENGL 371: Topics in Creative Writing) at the 400-level as ENGL 473. In total, only one additional course will be added to the number currently offered: the new ENGL 271 Introduction to Creative Writing. We anticipate that this course will increase enrollment in the newly established 300-level genre-specific courses.

All courses will use existing resources and faculty. We do anticipate an overall increase in enrollment in creative writing courses: our proposal for the minor arises from the great interest amongst undergraduate students, many of whom have expressed dissatisfaction with creative writing courses counting only as electives, or to fulfill (h) or (w) requirements. Many students are already involved in creative writing projects in their own time, projects for which the minor would provide the structure and guidance they are looking for.

# Departments and programs affected:

- 1. English Department: the English Department already has the faculty with the expertise necessary to offer the courses associated with the proposed minor. The proposed frequency of course offerings will mean that the number of undergraduate creative writing courses offered per year will remain at current levels.
- 2. Elementary Education: elementary education students are required to take:
  - ENGL 271 Introduction to Creative Writing: Fiction
- or ENGL 272 Introduction to Creative Writing: Poetry
- or ENGL 271 Introduction to Creative Writing: Non-Fiction
- or ENGL 314 Technical Writing
- or JRN 311 Magazine Article Writing

The Elementary Education program has been contacted and anticipates no negative impact from the current ENGL 271, ENGL 272 and ENGL 273 being replaced by the new ENGL 271 Introduction to Creative Writing (see email from Carol Barnhardt, Chair of Elementary Education).

# G. RELATIONSHIP OF THE PROPOSED MINOR'S OBJECTIVES TO THE "PURPOSES OF THE UNIVERSITY".

Shaping Alaska's Future asserts that to preserve local traditions, UA should position itself as "a major center of culture and the arts in Alaska." By offering a minor in creative writing, UAF will be further aligning itself with this mission, providing a means to nurture artistic talent and foster Alaska's culture in Interior Alaska. Undergraduate students whose passion lies in artistic and cultural expression through writing will be more likely to attend UAF if creative writing is offered as a formal part of their degree; by addressing their interests and providing a formal means to explore them, UAF will be more likely to engage and retain these students. There is existing demand from students for creative writing to form a recognized part of their degree program.

UAF already provides formal study of the arts at the undergraduate level in music, theatre and art. By formalizing creative writing, the arts programs offered at UAF overall will be strengthened.
