These programs require students to go through a formal admissions process; the timing and fees for such processes will be under the purview of the MAUs. As such, a high school diploma or its equivalency is required —and the student is eligible for federal financial aid. Students are recognized by Banner to be in a specific program (as opposed to non-degree seeking or undeclared) allowing tracking of enrollment, progress and graduation. Students participate in a unit-level graduation ceremony and receive a MAU standardized "Occupational Endorsement."

Brief statement of the proposed endorsement, industry objectives and abbreviated student learning outcomes assessment and implementation plan:

The Occupational Endorsement Rural Waste Management and Spill Response Technician is a one year program that educates and and trains students in rural solid waste handing, spill response across Alaska. It has committed partners including government, industry and NGOs that are currently involved in landfill operator training.

The OE emphasizes Alaska-wide education so that villages and tribes can enrolled students to gain the skills and experience necessary to implement solutions to solid waste stream challenges in their home communities. The OE introduces students to best practices for rural waste management that are in compliance with state and federal governmental regulations. Exceptional focus is placed on student diversity, workplace safety/planning, and learning outcomes. Upon completion of the OE, students will be prepared to help protect rural communities and address many of the environmental risks associated with rural solid waste disposal.
