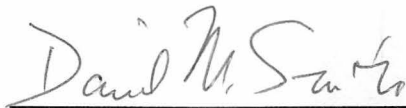

Colleges form interim Sabbatical Committees following the guidelines noted in the UAF Faculty Senate attachment 4 of meeting 5, September 9, 1988. These committees will function as sabbatical leave committees for each College/School. Each College/School will elect a Sabbatical Leave Committee of at least 7 members from the tenured members of the School/College. If a College/School has less than 7 members, the College/School must in consultation with the Faculty Senate, supplement their Committee with other tenured faculty members from within other Schools/Colleges at UAF.
