UAF GOVERNANCE COORDINATING COMMITTEE #43

October 23, 1998 Chancellor's Conference Room

Jean Richardson called the meeting to order at 10:05 a.m.

MEMBERS PRESENT: Christensen, S. Gatterdam, R. Richardson, J. Wilken, S.

The minutes to meetings #41 (March 13, 1998) and #42 (April 27, 1998) were approved as distributed via e-mail.

The agenda was adopted as distributed via e-mail.

ΤT COMMITTEE REPORTS

Health Issues - M. Combellick

Michelle Combellick was ill and unable to attend the

meeting.

Grievance Council - W. Martin

Wanda Martin was out of town. However, Kathy Mosca

stated that the Council is meeting on October 26 to address changes they would like to see in the grievance

procedure, prior to their meeting with Patty Kastelic, Executive Director, Statewide Human Resources. The committee has received a grievance for action.

C. Intercollegiate Athletics Committee - S. Wilken

The committee has met twice regarding the proposed changes to Board of Regents' Policy on Intercollegiate
Athletics. Both UAA and UAF athletic departments were
not contacted on the policy changes. Also, the policy
changes were forwarded without input from the
departments that would be impacted. The deans of
student affairs had recommended the changes and
Faculty Senate passed the proposed changes.

Major concerns were why the changes and what was the intent of the changes. The Coalition of Student Leaders are officially looking at this policy. This was not on the Board of Regents agenda in October but will probably be on the November agenda. Staff Council had not commented on the changes to date. However, this item will go to Staff Affairs for their October 28 meeting. Ron Gatterdam reminded committee members that governance bodies need to respond quicker to issues and that the Regents' are not going to tolerate delays. Sue Wilken stated that she had contacted Nanne Myers' office and the proposed changes were ready for distribution in May, but for some unforeseen reason, UAF governance bodies did not receive it until August.

The Intercollegiate Athletics Committee had requested a delay but the policy went forward to the Senate. Jean Richardson recommended that a subcommittee be formed consisting of students, members from Intercollegiate Athletics Committee, the director of Athletics, and the dean of students to review the policy. This meeting will be scheduled.

III OTHER BUSINESS

A. 1999-2000 Academic Calendar

Faculty Senate drafted the 1999-2000 academic calendar in conjunction with the Registrar and forwarded this item to staff and student governance bodies for action. Staff Affairs will address this item at their meeting on October 28. The students will place this item on their October 25 agenda.

B. Discussion on Staff Council Motion Passed on the Governance Coordinating Committee Procedures

Shannon Christensen addressed the recommended changes that Staff Council has made. The Staff Council passed a motion on October 9 to approve the changes in the procedures with the following amendments: Do not delete rural affairs, specify term lengths, and change Public Safety to Police Department in the Health Issues charge. The Faculty Senate has sent the procedures back to the Coordinating Committee to incorporate the amendments Staff Council has made. Students will add this item to their agenda. Ron Gatterdam asked for the rationale why the Rural Affairs Committee should not be deleted. Shannon Christensen stated that Staff Council voted to retain Rural Affairs so that this committee could assist in lobbying efforts. In the past this committee had not been active. Also, campus safety at the rural sites is a major area of concern. The procedures are pending student action, also.

C. Committee Vacancies

The following committees have vacancies: The Health Issues has both faculty and student vacancies. Intercollegiate Athletics has student vacancies and Jean Richardson will be appointing another student to the Coordinating Committee. Curricular Affairs has a student vacancy. If you are interested in serving on a committee, contact the Governance Office at fygcc@uaf.edu.

D. Schedule November and December Meetings

The November and December meetings were set for Friday, November 6 at 10:00 a.m. and Wednesday, December 2 at 11:00 a.m. Both meetings will be in the Chancellor's Conference Room. The early scheduling of the Coordinating Committee meetings will assist governance in promptly responding to issues.

IV GOVERNANCE REPORTS

A. ASUAF - J. Richardson

ASUAF scheduled candidate forums on October 13, 14, and 15; as well as coordinated a voter registration drive. There was a special election last spring for an all-sports pass, which failed. The issue has come up again via a petition and there will be a special election this November. The best case scenario is that the Regents will address this issue at the February meeting and the all-sport pass would not be effective until next fall. There is a Northwest Student Leadership Conference on November 13, 14, and 15, which Jean Richardson will be attending, along with three senators and two other students. Jean Richardson and a couple senators will be attending the November Board of Regents meeting in Anchorage.

B. Faculty Senate - R. Gatterdam

The major area of concern for the Senate this fall has been the union/Senate relations and personnel procedures. An issue of concern for students may be TVC offering classes outside their discipline. Diploma size may also be an issue, but hopefully not. The associate diplomas would be smaller than those for the bachelor's degree. Ron alerted students of a revision to the grade appeals policy from the Board of Regents' office.

C. Staff Council - S. Christensen

Staff Council is preparing for a retreat with President Hamilton on November 5 in Anchorage. Issues will include consistency in holiday closure, pay and personnel whereas staff are being asked to take on the duties of others but there job description does not reflect the additional duties. Campus safety both at the major MAUs and the rural sites will also be an issue.

Sue Wilken recommended more staff training, in areas such as PPA training and software training, etc. A recommendation was made to look into the training offered by Career Tracks with a possible group discount for University employees. Shannon Christensen stated that over the past three years, the Staff Training Committee has worked very hard to put forth a comprehensive training program for supervisors. Also, Carolyn Chapman will be traveling to some rural sites and provide the rural staff with training. The Training Committee is also looking at some skills based training with the Electronic Learning Center through the Gartner Group. Personnel will be handling the PPA training.

HEALTH ISSUES REPORT

The Committee met on October 13 to discuss the request by staff to extend UAF LIFE hours to include weekends. As this request was made by the Staff Council, the Health Issues Committee (HIC) voted in favor of formally putting this request to Randy Pitney, Interim Director of Athletics and Recreation. An e-mail was sent to Randy Pitney and a response from Athletics and Recreation Department was received. The department responded that it cannot commit to this request due to financial constraints at this time. It became clear that future requests must include how the department and the SRC will benefit from the request in terms of firm dollars and participant numbers.

The committee is working on several ideas that will hopefully provide incentives to UAF employees who have an SRC pass, or currently have a UAF LIFE pass. A short list for review follows--please keep in mind that these are "works in progress."

- 1. Individual (participant) tracking system of workouts for those using the facility to include all faculty and staff. It will be the exerciser's responsibility to track their individual workouts. A preestablished point system will be set up prior to the new semester. If, at the end of the semester, the goals of established points are met, the participant will receive a T-shirt. For those who did not meet the goal, but gave an honest effort, perhaps something like a "certificate of effort" could be presented. These details will be worked out prior to implementation.
- 2. Long term goal is to establish incentives into our current health care plan Blue Cross of Alaska and Washington for participants involved to better their health through an exercise program. The committee feels strongly that finding positive ways to provide faculty and staff incentives to exercise is one of its primary functions and goals.

UAF GOVERNANCE COORDINATING COMMITTEE PROCEDURES

INTRODUCTION

FACULTY, STAFF, AND STUDENT GOVERNANCE IS ESTABLISHED BY UNIVERSITY OF ALASKA BOARD OF REGENTS' POLICY. EACH GOVERNANCE ORGANIZATION OPERATES INDEPENDENTLY, BUT WITH FORMAL INTERCHANGES OF INFORMATION MADE POSSIBLE BY REPORTS AS PART OF REGULAR MEETINGS. FOR EXAMPLE, THE ASUAF AND STAFF COUNCIL PRESIDENTS ARE NON-VOTING MEMBERS OF THE UAF FACULTY SENATE, AND REPORT ON THE WORK OF THEIR INDIVIDUAL GOVERNANCE ORGANIZATIONS AT EACH MEETING OF THE FACULTY SENATE. THE FACULTY SENATE PRESIDENT ALSO DELIVERS A REPORT ON SENATE ACTIVITIES AT EACH MEETING OF THE STAFF COUNCIL.

ISSUES CAN ARISE WITHIN GOVERNANCE THAT REQUIRE THE ATTENTION OF MORE THAN JUST ONE GOVERNANCE BODY. IN SUCH A CASE, THE ISSUE CAN EITHER BE BROUGHT DIRECTLY TO EACH BODY BY AN APPROPRIATE INDIVIDUAL OR GROUP (E.G., ADMINISTRATION) OR IT CAN BE BROUGHT TO THE UAF GOVERNANCE COORDINATING COMMITTEE, WHICH IS THEN CHARGED WITH THE RESPONSIBILITY.

THE FUNDAMENTAL OBLIGATION OF THE COORDINATING COMMITTEE, ONE ASSOCIATED WITH THE REASON FOR ITS CREATION, IS TO ASSURE TIMELY CONSIDERATION OF AN ISSUE BY EACH GOVERNANCE BODY AND FINAL ACTION ON THE ISSUE: IT ACTS AS MONITOR OF PROGRESS AND GUARANTOR OF COMPLETION.

TO FURTHER AID THE COORDINATING COMMITTEE IN CARRYING OUT ITS OBLIGATIONS, IT ALSO SUPPORTS THE EXISTENCE OF CERTAIN STANDING COMMITTEES CONCERNED WITH CAMPUS-WIDE ACTIVITIES (SUCH AS THE HEALTH ISSUES COMMITTEE) AND RECEIVES REPORTS FROM OTHER COMMITTEES OUTSIDE ITS CONTROL WHO ARE ALSO CONCERNED WITH CAMPUS-WIDE ISSUES (SUCH AS THE POLICE ADVISORY BOARD).

THE COORDINATING COMMITTEE ALSO CREATES AD HOC COMMITTEES AS NEEDED TO ADDRESS PARTICULAR ISSUES NOT UNDER THE PURVIEW OF AN EXISTING COMMITTEE. THE PROCEDURES DETAILED HEREIN DEFINE THE STRUCTURE AND WORKING OF THE UAF GOVERNANCE COORDINATING COMMITTEE.

ARTICLE I Name

Sect. 1. The name of this organization shall be the UAF Governance Coordinating Committee

> Purposes, Responsibilities, and Authority ARTICLE II

- Sect. 1 The purposes of the UAF Governance Coordinating Committee are:
 - Α. The body will exist for the express purpose of coordinating unified action from the individual governance bodies and ((to establish conference committees)) to address issues of common concern. Provide a mechanism of communication between
 - В. the governance bodies.
 - ((Set up)) WORK WITH ((conference)) STANDING committees to consider issues affecting multiple C. constituencies. The committees will report to the UAF Governance Coordinating Committee ((and their respective governance bodies))
 - Appoint members to ((permanent)) STANDING D. committees AS NEEDED, ensuring that there is representation from each of the governance constituencies((,)). ((e))Exceptions TO COMMITTEE COMPOSITION will be made when agreed upon by all constituencies.
 - Ε. CREATE AND APPOINT AD HOC COMMITTEES AS NEEDED.
 - ((E))F. The body coordinates recommendations from the
 - STANDING AND AD HOC committees.
 The body will ((recommend)) COORDINATE THE ((F))G. REVIEW AND ACCEPTANCE OF the academic calendar((.)) UPON RECEIPT FROM THE FACULTY SENATE ADMINISTRATIVE COMMITTEE. THE COORDINATING COMMITTEE WILL SUBMIT THE ACADEMIC CALENDAR TO THE CHANCELLOR FOR APPROVAL.

ARTICLE III Membership

Sect. 1 The UAF Governance Coordinating Committee will consist of the president and president-elect, or their designee, of the three governance bodies. In the case of ASUAF, the senate president will serve on the UAF Governance Coordinating Committee. (For the purpose of identifying membership, the three governance bodies are the Associated Students of the University of Alaska Fairbanks, Faculty Senate, and Staff Council.)

ARTICLE IV Leadership

Sect. 1 The chairperson of the UAF Governance Coordinating Committee will be elected from its members for a one-year term, BEGINNING JUNE 1 AND ENDING MAY 31. The election will occur at the last UAF Governance Coordinating Committee meeting of the academic year, WHICH MUST FOLLOW THE COMPLETION OF ALL GOVERNANCE ELECTIONS.

ARTICLE V Committees

Sect. ((1))2 The ((conference)) STANDING committees of the UAF Governance Coordinating Committee shall include:

> ((Academic Computer Users Committee)) Intercollegiate Athletics Committee ((Chancellor's Advisory Committee on Public Safety, Transportation and Parking)) Rural Affairs Committee UAF Grievance Council Health Issues

- Sect. ((2))1 A. ((Conference)) STANDING committees shall have at least one representative from each of the governance constituencies, exception will be made when agreed upon by all constituencies.

 Terms of all ((conference)) committee members will
 - В. be one year for students and two years for faculty and staff.
 - C. Committee chairs will be elected from and by the respective committees
 - D. Committee chairs shall forward committee business to the UAF Governance Coordinating Committee for disposition, EXCEPT WHEN LIMITED BY UNIVERSITY OF ALASKA REGULATIONS.
 - E. Policy items from the ((conference)) STANDING committees must be forwarded to the individual governance bodies for action.
 - In addition to the committees' specific charges, the F. primary responsibility of the committees are formulation and oversight of university-wide policies under the purview of each committee.
 - Committees will meet ((at least monthly)) AS NEEDED during the academic year TO FULFILL THEIR DUTIES. G.
 - The chairs of the ((conference)) STANDING committees Η. will report recommendations at the monthly UAF Governance Coordinating Committee meetings.

Sect. 3 ((Conference)) STANDING Committees Charges

((A. Academic Computer Users Committee

> The charge of the Computer Users Committee shall be to:

- ((B. Chancellor's Advisory Committee on Public Safety, Transportation and Parking

The charge of the Chancellor's Advisory Committee on Public Safety, Transportation and Parking shall be to:

- review and make policy recommendations to the Chancellor and UAF Governance Coordinating Committee regarding campus safety, security, and the transportation system at UAF.
- 2. serve as an appeal board, deciding appeals regarding motor vehicle citations and privileges.))
- Intercollegiate Athletics Committee ((C))A.

The charge of the Intercollegiate Athletic Committee shall be to:

- exercise oversight of the direction of the 1.
- Intercollegiate Athletics Program. investigate compliance with NCAA and 2. . conference regulations.
- 3. participate in the evaluation of intercollegiate programs
- ((D.)) B. Rural Affairs

The charge of the Rural Affairs committee shall be to:

- oversee the general welfare of the UAF community not residing on the Fairbanks campus.
- monitor all activities affecting compliance with the Rural College mission statement of the University of Alaska Fairbanks.
- ((E))C. UAF Grievance Council

The UAF Grievance Council will administer grievance procedures and make recommendations in compliance with Board of Regents grievance policy and University regulations.

((F))D. Health Issues Committee

The charge of the Health Issues committee shall be to:

- address health issues which affect the work environment.
- 2. coordinate efforts with the Health Center, Fire Department, Risk Management, and ((Public Safety)) UAF POLICE to find solutions to health

issues.

- Sect. 3 Ad Hoc Committees may be established as demand warrants.
- SECT. 4 THE GOVERNANCE COORDINATING COMMITTEE WILL

 RECEIVE REPORTS FROM OTHER COMMITTEES OUTSIDE ITS

 CONTROL WHO ARE ALSO CONCERNED WITH CAMPUS

 ISSUES. EXAMPLES INCLUDE: POLICE ADVISORY BOARD,

 TECHNOLOGY BOARD, ONE-CARD COMMITTEE, AND ANY

 OTHER COMMITTEE DEEMED RELEVANT TO FACULTY,

 STAFF, AND STUDENTS.

ARTICLE VI Meetings

Sect. 1 The UAF Governance Coordinating Committee will hold monthly meetings during the academic year.

ARTICLE VII Quorum

Sect. 1 A quorum will constitute at least one member from each of the governing bodies.

ARTICLE VIII Parliamentary Authority

Sect. 1 The parliamentary authority shall be the latest edition of Robert's Rules of Order.

ARTICLE IX Amendments

- Sect. 1 Amendments to the Procedures require a two-thirds vote from each of the three governing bodies.
- Sect. 2 Amendments to the Procedures shall be forwarded to the Chancellor's office for approval.
