Box 2: Use this space to justify upper division, so something like advanced material requiring application of advanced concepts, significant writing assignments, etc.


Box 9: just use 3 per week not 3/15.

The last line formatting is not correct. Use this format and particularly the last line should read:

Note: per senate policy don't include "or permission of instructor" (there's been some processed with really good reasons, but otherwise the catalog already states that instructors may waive prereqs.)

Form: Box 21: typo "chosen" field.

Syllabus:

- · Prereqs missing;
- Amend to show that the course requires approximately 9 hours of effort per week including attendance of blended classes (if any) and out of class preparation. This complies with UAF policy and Carnegie credit rules.

- Provide more information on how the assignments are evaluated (rubrics, etc.).
- Provide a definition for "timely".
- No grading percentage shown for attendance: is attendance required/graded?
- Show more detail on the schedule to:
  - Show proof of concept that the course works, is high quality, etc.; and
  - o Shows that students will put in the required effort.

#### **HSEM 403:**

**Form**: Box 10: typos 2<sup>nd</sup> line: "will" Topics. Also at the end of this sentence, I'm not sure the way this is worded is in agreement.

#### Syllabus:

- Typos in Box 10 carry over to course description in the syllabus;
- Course goals missing
- Amend to show that the course requires approximately 9 hours of effort per week including attendance of blended classes (if any) and out of class preparation. This complies with UAF policy and Carnegie credit rules.
- Grading: papers need more detailed assessment info (e.g. rubric, etc.)
- Discussions:
  - o More detail on what constitutes lateness
  - o Is one post enough effort?
- Show more detail on the schedule to:
  - o Show proof of concept that the course works, is high quality, etc.; and
  - o Shows that students will put in the required effort.

### Syllabus:

- Separate Course Goals (general) and Student Learning Outcomes (specific)
- Is this course blended or asynchronous? Make sure all forms and descriptions match.
- Where do Discussions account in the grade?
- How do the peer-reviewed lessons account in the grade? This is mentioned, but unclear.
- Show more detail on the schedule to:
  - Show proof of concept that the course works, is high quality, etc.; and
  - o Shows that students will put in the required effort.

#### **HSEM 415:**

**Form**: Box 10: Typos in course description:

- 4<sup>th</sup> line: This course designed... should be "This course is designed...
- 5<sup>th</sup> line: ...principles of cyber. Is this correct? Shouldn't it be "....principles of cyber domain,...."
- 9<sup>th</sup> line: also missing "domain" after cyber.

#### Syllabus:

- Same typos carry over to the course description in the syllabus.
- Late policy. Is it 10% reduction per day up to 100%? If so, should make clear.
- Is this F2F, blended or 100% online. Should make it clear in the syllabus.
- Show more detail on the schedule to:
  - Show proof of concept that the course works, is high quality, etc.; and
  - o Shows that students will put in the required effort.

## Syllabus:

- Need student learning outcomes;
- Amend to show that the course requires approximately 9 hours of effort per week including attendance of blended classes (if any) and out of class preparation. This complies with UAF policy and Carnegie credit rules.

- Show more detail on the schedule to:
