#### **COURSE DESCRIPTION**

This course will be held in conjunction with the CRCD/EPScoR Co-Management Symposium and Producing Knowledge Together event. This event will create a space for dialogue and sharing to build understanding, relationships, and knowledge for the **advancement of co-management** of traditional and customary fish and wildlife resources critical to the well being of Alaska Native communities for the improvement of resource management for all of Alaska. This course will provide a progressive focus on shared goals/values of all fish and wildlife resource managers healthy ecosystems, healthy populations, resource abundance. Speakers, panelists, and participants include Tribal Government, State and Federal Agency, and University representatives.

#### **COURSE OBJECTIVES**

At the completion of this course students will be able to:

- 1. Describe the history and legal framework of subsistence management in Alaska;
- **2.** Define the term co-management and provide examples of existing co-management as well as developing co-management opportunities in Alaska today;
- 3. Identify the challenges to implementing co-management in Alaska; and
- **4.** Describe the benefits of and opportunities for community-based and community-led research in partnership with academic institutions to address local issues.

- **4.** Identification of opportunities for joint (community-based and university) research in their traditional area (or sample area).

The paper must include two written pages, typed in size 12 font with one inch margins, and in a professional writing style.
