## **COURSE DESCRIPTION**

This course will be held in conjunction with the Federal Subsistence Board (FSB) Western Interior Regional Advisory Council (WIRAC) and Eastern Interior Regional Advisory Council (EIRAC) regular fall meetings. This course will supply an introduction to the operations of the Regional Advisory Councils (RAC), their role in impacting subsistence hunting and fishing regulations in Alaska, and hands on learning during the advisory council meetings.

# **COURSE OBJECTIVES**

At the completion of this course students will be able to:

- **1.** Describe FSB RACs basic operations in the establishment of subsistence hunting and fishing regulations;
- 2. Identify the components of the FSB regulatory proposal process;
- **3.** Identify the components of providing effective testimony at FSB, RAC, and regulatory meetings.
