<u>Issues to Highlight</u>

Compensation -

The Board of Regents met in Anchorage on November 30 and December 1. The board voted to approve the FY11 budget and included a 3% across the board staff salary increase in that budget. On Monday Gov. Parnell issued his budget. The governor's budget includes funding for the Life Sciences Building at UAF. It also includes the 3% amount for staff salaries. There is, however, a substantial difference between the Regents operating budget and the Governor's operating budget, mostly due to program money.
